

General Order #17
Series 2019-2020
15 March 2020

1. The following five requirements are in effect until the COVID-19 pandemic has ended, according to the US Centers for Disease Control and Prevention (cdc.gov), in the United States of America.
 - a. A Department Encampment may be conducted via remote audio, video, or both conferencing. Postponement according to General Order #15, Series 2019-2020 may be utilized to allow the coordinating of remote participation.
 - b. Brothers must be sent two weeks' notice via email, or the US Postal Service for those Brothers without an email account or an invalid email account, of their ability to use this option.
 - c. The Department Commander must insure that Brothers are in good standing and if each is entitled to vote or not.
 - d. The Department Commander must insure all remote Brothers have a chance to express his opinion.
 - e. Votes on the remote conferencing must be by voice and if any vote is contested one way or another, the Department Secretary will call for a roll call vote. There will be no showing of hands voting.

2. Because the Constitution and Regulations is moot on remote participation, as of July 1, 2020 forward - No Brother can participate in a Department Encampment or Camp meeting remotely via electronic means.

GENERAL ORDER 03 (SERIES 2019-2020)

2020 Department Encampment postponement

• Opening Comments

Verna Griffith (Camp Auxiliary), Ginger Trokey (DUVCW), and Rachel Peak (WRC) were recognized in attendance.

A moment of silence was held for the wife of Dept. Graves Registration Officer David Jackson, who passed away unexpectedly on February 9.

• Officer Reports

Commander Jeff Burgess addressed the status of the effort to get legislation passed to authorize the SUVCW to build a Union soldier memorial on Wesley Bolin Plaza. A meeting between some SUVCW officers and a Democrat state legislator in December resulted in the same advice we'd been given previously - that we must have a Republican sponsor for the bill. Dept. Civil War Memorials Officer John Conrad was subsequently unable to get a response from Republican Senator Michelle Ugenti-Rita, who had temporarily offered to help us last year. In other words, it seems we have no chance of getting the bill passed until the composition of the Legislature changes - which might happen in November.

Camp Secretary/Treasurer Jerry Bloom reported that the Camp's finances are in good health, and that he was working on collecting the 2020 dues.

Camp Graves Registration Officer Avery Frantz provided an update on the gravestone dedication ceremony he was planning at Tempe's Double Butte Cemetery for Union veteran Jared Riker. We reviewed the SUVCW's headstone dedication service and realized the biggest obstacle to setting the ceremony's date was finding an honor guard to fire a salute. It was agreed we'd explore all possibilities to find one.

Commander Jeff Burgess read a report submitted by Department JROTC Coordinator Bob Archibald that the U.S. Air Force had reinstated a recently rescinded regulation that no member could wear "ancestry based" medals or badges on their uniforms.

General News and Information

The GAR Badge

I think most of us are familiar with the GAR badge but what do all of its symbols stand for? To help, I take the following information from Beath's *History of the Grand Army of the Republic* published in 1889 (which I am fortunate to possess). But before I get to that, just what were the early badges made from? "For several years prior to 1884, the metal used in the manufacture of these badges was from guns purchased of various societies to whom they had been donated by Congress for monumental purposes; since then captured cannon have been used, which were purchased direct from the government and selected from guns stored at Governor's Island. These guns were made by Noble Brothers, Rome, Georgia; Quimby & Robertson, Memphis; John Clark, New Orleans and A. B. R. Brothers, Vicksburg. Three were presumably of English make, being better finished and free from iron or lead."

Even earlier than this, a reference to captured canon and GAR badges was noted. On June 8, 1880, G.A.R. Commander-in-Chief William Earnshaw, in his address to the Fourteenth Annual Session, said in part: "I succeeded in getting a bill introduced in Congress, to appropriate six captured cannon from which to make badges. Said bill was referred to the Military Committee, but as yet has not been reported on. The necessity of the case was such that we were forced to proceed in some other way, and I am pleased to say that, by the generosity of the president [Grant], a cannon was secured from which has been made over twelve thousand badges, and they are now worn by comrades of the order in all parts of the land." (Wouldn't you love to have one of these?)

Anyway, "...the design, which was described in circular No. 2, Headquarters Washington, D. C., February 18, 1870 as follows:

DESCRIPTION OF THE BADGE

The badge is of bronze, made from cannon captured in different decisive battles during the late rebellion, and in form a five-pointed star, similar in design to the two hundred medals of honor authorized by act of Congress to be given to soldiers and sailors most distinguished for meritorious and gallant conduct during the late war.

The design, as here given, and adopted by the Grand Army of the Republic, was arranged by General F. A. Starring, Inspector-General of the Order.

THE OBVERSE



In the centre of the badge is the figure of the Goddess of Liberty, representing LOYALTY; on either side a soldier and a sailor clasping hands, representing FRATERNITY, and two children receiving benediction and assurance of protection from the comrades, representing CHARITY. On each side of the group is the National Flag and the Eagle, representing FREEDOM, and the Axe or Bundle of Rods, or Fasces, representing UNION. In each point of the star is the insignia of the various arms of the service, viz: the *Bugle* for Infantry, *Cross Cannon* for Artillery, *Cross Muskets* for the Marine, *Cross Swords* for Cavalry and the *Anchor* for Sailors. Over the central group are the words, "Grand Army of the Republic," and under, the word and figures, "1861—Veteran—1866," commemorating the commencement and close of the rebellion, and also the date of organization of the Order.

THE CLASP

Is composed of the figure of an Eagle, with Cross Cannon and Ammunition, representing Defence; the Eagle with drawn sword hovering over and always ready to protect from insult or dishonor the National Flag, which is also the Emblem and Ribbon of the Order.

THE REVERSE SIDE

Represents a Branch of Laurel—the crown and reward of the brave—in each point of the star. The National Shield is the centre, surrounded by the twenty-four recognized Corps’ badges, numerically arranged, each on a keystone and all linked together, showing they are united, and will guard and protect the Shield of the Nation. Around the centre is a circle of stars, representing the States of the Union and the Departments composing the Grand Army of the Republic?

GAR and USWV marker

In February of 2020 Picacho Peak Grave Registrations Officer Avery Frantz was notified by Leon Garlinghouse of Globe, who is the descendant of a Union and WRC Grandparents buried in the Globe City Cemetery, of a GAR and USWV [United Spanish War Veterans] Memorial within the GAR section of the cemetery.

According to the Silver Belt Newspaper the column of native stone was erected in 1911 in honor of G. A. R. and Spanish American War veterans by private subscription.

The stone column stands on the left of famous Union veteran Al Sieber's grave. Mr. Leon Garlinghouse is a true native of Arizona with his family coming to Arizona in the 1870's. He is a prospective member of the SUVCW and SCV.
