## Department of the Southwest

On September 11, 2015, we received our Camp charter and we were the third and last Camp in Arizona to be a “camp-at-large.” We are now part of the Department of the Southwest, Sons of Union Veterans of the Civil War.

This is truly historic occasion in the life of the SUVCW in Arizona. From 1995 to 2014 Arizona had one camp-at-large and that was Picacho Peak Camp No. 1. During this time we fended off several officers to join existing departments but as the years progressed it became obvious that either we create our own Department or we would more or less be forced into joining one.

In 2015 we were able to charter the General R. H. Minty Camp No.2 in Tucson and the General U. S. Grant Camp No. 3 in Flagstaff (*totally because of you*). We needed a minimum of 3 Camps to form a Department so we were on our way. By a previous agreement with the National Organization SUVCW, if we raised the requisite number of camps and filed a petition to form a Department we would also acquire New Mexico (which currently has no Camps and was part of the Department of Texas).

On December 3, 2015, our Department of the Southwest became a reality! Now the work continues.

### Program speaker

Our Senior Vice Commander and Chaplain, Brother Mark Haynes, was our guest speaker and did such a good job that we will have to have him back for another talk. His talk was “The Search for Ebenezer.”

Here is what he had to say:

The phone rang and I recognized the voice on the other end immediately. It was my cousin, Olive Richardson, the unofficial keeper of the family genealogy. She lived near Somerset, Kentucky, in a little area called Cabin Hollow. She and her sweet husband lived down an old gravel road which led to their modest little cottage.

“Mark?”

“Yes, Olive?” I replied.

“Whatever happened to Ebenezer? Do you think you can find him?”

I told her I would try. Olive was talking about an ancestor of ours, Ebenezer Thompson Haynes. Ebenezer was the son of Hezekiah Haynes, an old wild man who was a War of 1812 veteran. Hezekiah had married Margaret “Peggy” Edwards on December 1, 1831, when he was 46 years old and she was barely 16! Ebenezer was the sixth of eleven children. Ebenezer’s baby brother, Jesse, was my great grandfather.

Hezekiah died drunk in the Pulaski County, Kentucky jail on October 2, 1852. Life was very hard for the Haynes family as they were simple farming folks. With Hezekiah gone, Peggy and her children lived the best they could off the land of Pumpkin Hollow.

Ebenezer Thompson Haynes was born on November 20, 1841. He and a bother just older than him, Francis Marion, served during the Civil War on the Union side. Ebenezer enlisted on September 11, 1861. He was a member of the Kentucky 1st Cavalry,



Company L. The 1<sup>st</sup> Kentucky were known as the “Wild Riders.” They were feared and respected by the enemy.

Olive told me that she knew Mary “Peggy” Haynes as a child. Peggy lived until June 22, 1911, and is believed to have been the last surviving widow on pension as a War of 1812 widow. Ebenezer disappeared during the Civil War and the years had clouded the memory of what had happened to him. It bothered Olive and apparently Ebenezer’s mother did not know the full story. One family legend said that he died in the Belle Isle Prison. I set out to find Ebenezer for my little Cousin Olive.

The National Archives provided me with Ebenezer’s military record. It showed the date of his mustering in to Camp Dick Robinson. The Kentucky 1st was a very active unit. Among the battles they were involved in were Mill Springs and Perryville. As I looked at Ebenezer’s record, things looked pretty routine until I came across this phrase – AWOL. THAT didn’t look good! I sure had no desire to tell Olive that our uncle had turned tail and ran from his duties! As I continued to look at his record, I saw that a few months later he was back with his regiment and was not disciplined for his unauthorized departure. It seems that he owned his own horse and was welcomed back with open arms. From what I was able to determine, Ebenezer probably returned home to help his widowed mother with planting. It seems there were a large number of the boys who had done the same thing.

One other thing stood out when I looked at the record of Ebenezer Thompson Haynes. I came across the word “Captured.” Apparently, during action at or near Philadelphia, Tennessee, on October 18, 1863, he was captured by Confederate forces. This, I thought, could perhaps confirm that he was taken to Belle Isle. Further research caused me to find another dreaded word –

ANDERSONVILLE. The very word conjures up images of emaciated prisoners and profound suffering. I wondered if that had been Ebenezer’s fate.

My family and I were on the road raising financial support for our mission work on the Navajo Nation. We had a meeting in a church in Georgia. I told the family we were going to Andersonville. The night before we were to go, there was a movie on television simply entitled *Andersonville*. It was with great interest that we all watched the Hollywood version of what happened there. I have no doubt that it was not entirely accurate, but my heart was still moved by what I saw. We stopped at the National Park Headquarters at Andersonville. A very nice lady began to look for some records for me. “Here it is,” she said. “Would you like to know where it is?” I told her that I did. We

were given a map that lead to Grave #4970. On August 7, 1864, like so many others, he had died of scorbutus (scurvy) from a lack of proper nutrition.

We stopped at the grave and I got out of the car. I walked over to the grave and knelt there. “Mom, what’s wrong with Dad?” my little children asked. They wanted to know why Daddy was crying at the stone. It was not contrived. The tears flowed freely. I thought of a young Kentucky farm boy. He said goodbye to his mother and family after helping with the planting. When mother said goodbye to her son, she had no way of knowing that it would be the last time. Like so many other brave lads, many in a conflict that they did not completely understand nor realize the scope thereof, Ebenezer Thompson Haynes gave the last full measure. I was not sorry to be weeping for him. Someone needed to. It had been too many years since someone had.

The phone rang at the little cottage in Cabin Hollow. Olive Richardson picked up the receiver.

“Hello? Mark, is that you?”

“Yes, Olive, it’s me. I wanted to let you know something. I found Ebenezer.”

Dedicated to the memory of Ebenezer Thompson Haynes and all the young men on both sides of the Great Conflict that never got to come home.

### Departments

Here is some information concerning Departments taken from the SUVCW regulations:

#### CHAPTER II DEPARTMENTS

##### Article I Formation

Section 1. Upon the formation of a Department, there shall be issued to it a Charter under the hand and seal of the Commander-in-Chief.

Section 2. Each Department shall be governed by its Department Encampment, subordinate to the National Organization.

Section 3. Upon the formation of a Department, there shall be called a special Department Encampment to be held at such time and place as may be designated by the Commander-in-Chief. At such special Encampment, complete organization of the Department shall be effected, including election of Officers and adoption of Department By-Laws. The Officers elected at such special Encampment shall serve until the annual Encampment, and shall be entitled to all honors accorded Officers completing an elective term.

Article II Membership Section 1(a). The membership of the Department Encampment shall be constituted as follows: all Past Commanders-in-Chief, Past Department Commanders and Past Camp Commanders, in good standing, who have served a full term or having been elected to fill a vacancy have served to the end of that term, the sitting Department Commander and the sitting Camp Commanders. One delegate from each Camp, whatever its membership and one additional delegate for every ten Brothers, or major fraction thereof, based upon the report for the annual report next preceding the Encampment; and its own elective officers (except Aides).
