An "APPLICATION FOR PERMISSION TO FORM A CAMP OF THE SONS OF UNION VETERANS OF THE CIVIL WAR" namely the General U. S. Grant Camp No. 3, Flagstaff, Arizona was approved on December 8, 2014. (Grant Camp is the third SUVCW Camp to be organized in Arizona, thus the No. 3.)

On August 22, 2015, the General U. S. Grant Camp No. 3 held its organizational meeting at the Sizzler Restaurant, 3540 Historic Route 66, Flagstaff, Arizona.

On August 31, 2015, the appropriate forms were submitted to the SUVCW National Secretary for review and approval of the Commander-in-Chief for an official Camp Charter.
