### GENERAL ORDER - 07 Establishment of the Department of the Southwest

On November 17, 2015, I received a request from the following Camps to form a Department.

- Picacho Peake Camp No. 1 of Phoenix, Arizona
- General R. H. G. Minty Camp No. 2 of Tucson, Arizona
- General U. S. Grant Camp No. 3 of Flagstaff, Arizona

In accordance with National Regulations, Chapter II, Article I, Section 7, the petition of said Camps is approved and the **Department of the Southwest** is hereby established and shall be composed of the states of **New Mexico and Arizona**. The Department of Texas is commended for its past stewardship of the state of New Mexico. The Date of Rank for the Department of the Southwest is: December 3, 2015.

The Department of the Southwest is hereby authorized to hold a Special Department Encampment to complete the organization of the Department, including the election of Officers, Delegates to the National Encampment, and the adoption of Department By-Laws.

Ordered this 3<sup>rd</sup> day of December, 2015, in the Town of East Berlin, Pennsylvania.

## DEPARTMENT ORDERS

### Department of the Southwest Sons of Union Veterans of the Civil War

#### GENERAL ORDER 01 (SERIES 2016-2017)

##### Organization of the Department and Activities

By the authority vested in me as Commander of the Department of the Southwest of the Sons of Union Veterans of the Civil War, the National Constitution and Regulations, the National policies, and the Department Bylaws, the following is ordered:

1. At Scottsdale, Arizona, on March 26, 2016, the Delegates to the Initial Department Encampment elected me to the highest post in the Department. I am honored to serve my brothers in this capacity, and will do all in my power to establish the Department organization and activities to promote its success.
2. Headquarters of the Commander is hereby established at 33214 N. 61<sup>st</sup> Street, Scottsdale, AZ 85266-8206. All correspondence for the Commander may be posted to that address. Email can be sent to [jrconrad@post.harvard.edu](mailto:jrconrad@post.harvard.edu). Email is my preferred communications method, for those of our brothers who have email access. My phone number is 602-750-0938.
3. Correspondence concerning Department or Camp activities, finances, reports, and membership should be directed to Department Secretary-Treasurer Dale E. Enlow, 7723 E. Treeline, Hackberry, AZ 86411, 928-715-5109, [dale\\_enlow@hotmail.com](mailto:dale_enlow@hotmail.com).
4. **All Brothers are strongly encouraged to participate in Memorial Day ceremonies on May 30, 2016. We should continue to honor the memory of our forefathers who sacrificed to keep the Union together. Each of the camps is participating actively in a local community remembrance. Our sisters in the DUVCW and the Picacho Peak Camp No. 1 Auxiliary are also participating in Memorial Day ceremonies.**
5. To promote efficiency in the Department, the roles of Graves Registration Officer, Eagle Scout Coordinator, ROTC Coordinator, and Signals Officer/Webmaster are consolidated at the Department level rather than the Camp level and led by, respectively, Brothers Jan D.

Huber, Dennis W. Lamb, Robert E. Archibald, and Jeffrey D. Burgess. The respective Camps are encouraged to amend their By-Laws as necessary to effect this change at the local level.

- 6. The current website for Picacho Peak Camp No. 1 shall be converted to a site for the Department as a whole, with each Camp and the Auxiliary having its own page. Signals Officer/Webmaster Jeffrey Burgess will work with the Department and Camp officers to effect this change. Any individual Camp Facebook or similar social media pages will include a link to the Department website.
- 7. The individual Camp Newsletters will be consolidated into a quarterly Department Newsletter prepared by Brother David Swanson, with space devoted to each Camp and Auxiliary. - 8. Minty Camp Commander Robert D. McCord will lead and coordinate Picacho Peak Days participation with the Minty and Picacho Peak Camps.
- 9. A vacancy having arisen, I appoint Brother H. Allen Nash to serve as Department Patriotic Instructor and thank him for his willingness to serve.

### Short History of the Department of the Southwest

Well, we are all part of a truly historic occasion in the life of the SUVCW in Arizona. From 1996 through 2014 Arizona had one Camp-at-Large and that was Picacho Peak Camp No. 1. During this time we fended off offers to join existing Departments but as the years progressed it became obvious that either we create our

own Department or we would have to join an existing one. Picacho Peak Camp Brothers voted at least twice over the years to remain a Camp-at-Large rather than join an existing Department anticipating that someday we would have enough Camps to form our own Department.

In 2015 we were able to charter the General R. H. G. Minty Camp No.2 in Tucson (organized by John Conrad) and the General U. S. Grant Camp No. 3 in Flagstaff (organized by David Swanson). We needed a minimum of 3 Camps to form a Department so we were on our way. By a previous agreement with the National Organization SUVCW, if we raised the requisite number of camps and filed a petition to form a Department we would also acquire New Mexico (which currently has no Camps and was part of the Department of Texas).

On December 3, 2015, our Department of the Southwest was established and on March 26, 2016, received its Charter! Now the work continues.

#### **February 23, 2016, Camp Meeting Information**

The regular quarterly meeting of Picacho Peak Camp No. 1 and its Auxiliary was held at noon on February 13, 2016, at the Deer Valley Airport Restaurant. Thirty Brothers, Sisters and guests were in attendance. The meeting was led by Camp Commander Jerry Bloom.

#### **Camp officer reports:**

ROTC Coordinator Bob Archibald gave a report regarding the program and the schools which are part of it as follows:

“SUVCW JROTC certificates and medals have been received and will be forwarded to seven area high schools. We will have Chapter members making presentations for other organizations and will also do the honor for us at Deer Valley, Independence, Greenway, Glendale and Red Mountain high schools. In addition, awards are being sent to two small outlying schools at Ray and Globe which do not see as many honors given from National Organizations.

We ask that Chapter members come forward to nominate schools for future awards and to make the presentations. The presentation itself is a short and simple act but you will find that it is a very rewarding experience to be a part of the ceremonies.”

Bob also discussed the various funding options available for the proposed monument to the California Column in the Wesley Bolin Memorial Plaza in Phoenix.

Secretary/Treasurer David Swanson gave a short report on the camp finances which are in good shape and a report about membership dues.

**Camp Patriotic Instructor** Bob Massey presented some very interesting and obscure information regarding an interview procedure used by the Union for Confederate prisoners of war and that is an actual pre-printed “fill in the blanks” form to be used by the interviewer. Brother Massey had a copy of the printed form that was actually used in an interview with a nineteen year old prisoner named Private Isaac Emmons, Co K, 23<sup>rd</sup> Mississippi Vol. Infantry

Some of the questions are:

I was in arms against the United States and was a [rank] \_\_\_\_\_ in Company \_\_\_\_\_. I was sworn into the Rebel service about the \_\_\_\_\_ day of \_\_\_\_\_ 186\_ by \_\_\_\_\_ in \_\_\_\_\_ County for \_\_\_\_\_ years.

How many times have you been in arms during the rebellion? What commanders have you served under? What battles and skirmishes have you been in? Did you have arms, or were you out on picket, at what part did you take in the action? Was there any rebel camp near you that you did not give notice of to the U.S. troops?

A final question is: “Do you sincerely desire to have the Southern people put down in this war and the authority of the U.S. Government over them restored?” To which Isaac truthfully answered: “I do not.”

## 150<sup>th</sup> Anniversary of the Grand Army of the Republic

April 6, 2016, was the 150<sup>th</sup> Anniversary of the Grand Army of the Republic. This nationwide organization was composed of Union veterans of the Civil War who, because of their sacrifices, saved the United States of America.

On April 6, 1866, the Grand Army of the Republic (also called the G.A.R.) was formed. This veterans organization of Union Civil War soldiers, sailors, marines, and members of the Revenue Cutter Service became the largest and most influential veterans organization of its time and as such was a social and political force that would control the destiny of this nation for six decades. In the 1890s it had over 490,000 members. All U.S. presidents including Ulysses S. Grant, Rutherford B. Hayes, James A. Garfield, Benjamin Harrison, and William McKinley were members. In fact from 1869 to 1901 only one president was not and that was Grover Cleveland.

The Grand Army of the Republic was organized just as the American Legion, VFW, and similar veterans organizations are today with national, state, and local departments and posts; the big difference is that after the last Compatriot died in 1956 the G.A.R. ceased to exist.

On May 5, 1868, G. A. R. Commander-in-Chief General John A. Logan issued General Order 11 which instituted Memorial Day as a nationwide observance.

We, as members of the Sons of Union Veterans of the Civil War (SUVCW), the congressionally chartered successor organization to the G.A.R., are proud of our Civil War ancestors' sacrifices which, collectively, saved this Union of states!

## The Burnside Post Grand Army of the Republic and Memorial Day

Our organization, the Sons of Union Veterans of the Civil War, is the Congressionally Chartered successor to the Grand Army of the Republic. I have written and compiled quite a bit of information about the early Department of Arizona GAR but a picture is worth a thousand words.

In February my wife Jan and I drove to Tombstone, Arizona to view the Burnside Post GAR memorial marker that is located there (it had been so many years since I had seen it I forgot which cemetery it was in).

Notice in the pictures that the dedication date is May 30, 1887, Memorial Day! The GAR was instrumental in making this a national day of observance and each of the Posts nationwide took this obligation very seriously. Wouldn't it be interesting to see who from the Post and the town were present? I'm sure that Burnside Post Commander B. A. (Benjamin) Fickas, the mayor, and other dignitaries would have given their patriotic speeches along with remembrances of the war (it only ended 22 years prior). I wouldn't doubt that this was all a culmination of a parade down the main street of Tombstone led by the Post Comrades in their GAR uniforms. The marker is in the GAR section of the cemetery so you know all of those graves were decorated with flowers as well.

Burnside Post Commander B. A. Fickas (as far as I can determine) was a private in Company A of the 143 Regiment, Indiana Infantry during the Civil War.

Burnside Post No. 36 was named for Major General Ambrose Everett Burnside. The Post was mustered in with a membership of 13 in 1882, as part of the Department of California Grand Army of the Republic, in Tombstone, Arizona Territory. It was still part of the California Department on Memorial Day 1887.

Arizona didn't have its own Department until September 1887 when the six California Posts located

throughout the territory were transferred to the Provisional Department of Arizona and in January 1888 the permanent Department of Arizona Grand Army of the Republic was official. With the transfer, the Burnside Post number was changed from 36 to 2 and its membership had increased to 47 Comrades. The Post surrendered its charter in 1901.

Oh, in case you are wondering, the marker is located in the Tombstone Cemetery, not the Boot Hill Cemetery and the shoot out at the O.K. Corral happened just a few years earlier on October 26, 1881. So Wyatt Earp was long gone from Tombstone but the GAR was alive and well!
