Her efforts have strengthened the Allied Orders in the Department of the Southwest and promoted a spirit of comradery and cooperation among the three Orders in the jurisdiction of the Department.

Bylaw changes

The Elected department officers and delegates voted unanimously to several changes to the Department bylaws. Below is a summation of the changes:

Article III Membership (Article 1): Requires that Brothers under the age of 18 years of age be accompanied by a parent or person designated as a guardian (grandfather, brother over the age of 18 years, or uncle) when participating in any SUVCW activity. Brothers aged 18 or over should complete the free training from the Boy Scouts of America <http://www.myscouting.org>

Article III Membership (Section 2): The revision clarifies the previous section and provides that Brothers who reside within the boundaries of the Department of the Southwest must be a member of a Department of the Southwest Camp. There is no Department Member-at-Large classification.

Article VII Department Council: Add the following responsibilities to the Council: The Council is responsible for ensuring that a complete slate of nominees for the "Elected Department Officers" is prepared and presented to the Department Commander for use at each annual Department Encampment

Article VIII Finances: Clarifies that all Brothers (including Life members) pay the Department tax only to their primary camp. They do not pay a Department tax on dual memberships in other Department camps.

Article IV Encampments: Eliminates information contained in the section and replaces it with information that membership at the Annual Department Encampment shall be according to the current National Constitution and Regulations. (The exiting provisions went beyond what was allowed in the National Regulations.)

Department of the Southwest Dues: A \$3.00 per year increase in annual dues to the Department was approved. This is not retroactive and is applicable on any new memberships and dues in 2018 and beyond.

GENERAL ORDER 01 (SERIES 2017-2018)

Change of Command and Department Activities

By the authority vested in me as Commander of the Department of the Southwest of the Sons of Union Veterans of the Civil War, the National Constitution and Regulations, the National policies, and the Department Bylaws, the following is ordered:

1. At Phoenix, Arizona, on March 11, 2017, the Delegates to the First Department Encampment elected me to the highest office in the Department. I am honored to serve my Brothers in this capacity, and will do all in my power to promote the success and growth of the Department and its activities.
2. Headquarters of the Commander is hereby established at 4851 E. Fernwood Court, Cave Creek, AZ 85331. All correspondence for the Commander may be posted to that address. Email can be sent to me at: swanson1854@yahoo.com and my phone number is 480-599-9143.
3. Correspondence concerning Department or Camp activities, finances, reports, and membership should be directed to Department Secretary-Treasurer Dale E. Enlow, 7723 E. Treeline, Hackberry, AZ 86411, 928-715-5109, dale_enlow@hotmail.com.
4. As heirs to the Grand Army of the Republic, all of the Brothers of the SUVCW swore to protect May 30th as Memorial Day—since this was the day set aside by those Comrades who saved our Union. I encourage the Camps to have some sort of ceremony on this day but if not possible Brothers should at least fly the flag of the United States in tribute. Additionally, I strongly encourage Camps to participate in the National Memorial Day ceremony to be held on Monday, May 29, 2017, in their local communities. Remember, Memorial Day honors all of those who “gave their last full measure of devotion” in saving our country during any war or conflict.
5. All of the Camps should actively participate in presenting SUVCW flag certificates to those individuals and companies who patriotically display the grand flag of the United States. Camps should keep a record of their actions in this regard and notify the editor of the Department newsletter.
6. Restrictions established for the monitoring of members under the age of 18 while interacting with the SUVCW and its Departments and Camps. All Camps must revise their respective bylaws to include specific information which is

contained in PCinC Freshley’s General Order No. 22. Either Department Secretary Dale Enlow or I can be contacted for the exact wording or it can be found on the SUVCW website. Camp commanders will make their membership aware of this requirement since it is an important safeguard for all of our Brothers and current or future members under the age of 18.

7. Monument Committee: A committee comprised of Brothers Jeff Burgess (chairman) and John Conrad PDC and others as appropriate is formed with the purpose of getting a monument to the California Column placed at the Wesley Bolin Memorial Plaza in Phoenix or other appropriate site.

8. I thank all of the Brothers of the Department of the Southwest and its Camps for their membership since without it we would not exist! I encourage Brothers to actively support their Department and Camps by volunteering for programs and the various officer position opportunities.

General News & Information



Approaching the 130th Anniversary of the Department of Arizona Grand Army of the Republic

Starting with the October 2017 newsletter and throughout 2018 I will be posting information about the Department of Arizona GAR which was officially organized on January 17, 1888. Stay tuned!



James Winfield Staples

James Winfield Staples was born on July 14, 1838 in New Bedford, Massachusetts. On December 2, 1861, he joined General Gustavus A. Scroggs' Eagle Brigade in New York City. This brigade later became the 78th Regiment New York Volunteer Infantry and James Staples was appointed Sergeant Major of the regiment on April 24, 1862.

On August 9, 1862, Sergeant-Major Staples saw his first action at the Battle of Cedar Mountain, Virginia (Cedar Mountain is about eight miles south of Culpepper on Cedar Run). After this battle, he marched north toward Warrenton, Virginia. About six miles southwest of Warrenton the regiment engaged the Confederates in skirmishes on the 24th, 25th, and 26th of August 1862. These skirmishes are referenced in the official records as "Action at Sulphur Springs" or

"Action at Warrenton Springs." Six more days of marching brought the 78th New York to Manassas, Virginia, where on August 30, 1862; the Second Battle of Bull Run was fought.

After this battle, the 78th New York marched north with the Army of Virginia across the state line into Maryland to a place near where Antietam Creek joins the Potomac River near the border with West Virginia. There, on September 17, 1862, Sergeant-Major Staples fought in the Battle of Antietam. He fought well and, during the course of the battle, received a battlefield commission upon the death of Captain Peter M.T. Mitchell. On that day, he became Captain of Company I of the 78th New York Infantry Regiment. He was 24 years old at that time. He resigned his commission and was Honorably Discharged from the U.S. Army on April 4, 1863 at the Army of the Potomac's XII Corps Headquarters at Stafford Court House, Virginia.

After the war, he moved to San Francisco, California, joined the Grand Army of the Republic (GAR), and was subsequently elected as Department Commander of the Department of California. On August 4, 1886, the GAR held its 20th National Encampment in San Francisco and the *San Francisco Daily Morning Call* printed a special edition for the event. James Winfield Staples was referenced as a Past Department Commander in that special edition. James

Staples also became a member of the California Commandery of the Military Order of the Loyal Legion of the United States, Insignia Number 1696. James Winfield Staples died on December 23, 1890 in Oakland, California and was buried in Mt. View Cemetery in that city.
