

John Wren Owen, 1822-1877 **Twice elected Treasurer of Maricopa County** Captain, Company F, 7th California Infantry Infantry Served at Fort Mason, Santa Cruz County November 30, 1864-April 13, 1866



John Yours Truly Smith, 1831-1903 Married at Prescott October 3, 1875 Second Lieutenant, Company H, 4th California

The railroad station and the town of Benson, Cochise County, was named for him.

Served in the United States Army from February 28, 1866 to November 14, 1885.

Discharged from the California Volunteers at the Presidio of San Francisco January 31, 1865.

Post commander at Fort Whipple from: September to: December 1865.

Commissioned at San Francisco, Major, 4th California Infantry, May 22, 1865.

Mustered-out at Los Pinos, New Mexico Territory, August 31, 1864.

Promoted Captain, Company F, 1st California Cavalry, July 16, 1863.

Commissioned at San Francisco as First lieutenant, Company I, 1st California Cavalry, August 16, 1861.

Located a mining claim in the Tombstone District October 2, 1879.

Mustered-out at Fort Craig, New Mexico Territory, August 21, 1861.

Mustered-in as Sergeant, Company G, 1stCalifornia Cavalry, at San Francisco, August 19, 1861.

Enrolled at Nevada City, Nevada County, California, August 10, 1861.

Calderwood Peak lies between Agua Fria and New Rivers is named after Captain M. H. Calderwood.

For twenty-five years M. H. Calderwood ran the stage crossing of Agua Fria River on Black Canyon Road. The station was some 6 miles from present town of Marinette.

Speaker, Ninth Legislature, 1877.

Stationed at Tubac in 1865 and at Fort Mason in 1866.



The Prescott Courier of October 3, 1895, stated:

Felix Campbell of Capt. Hargraves company, 1st California Volunteers, discharged at Ft. Whipple, August 1864, goes today to the Soldiers' Home, Santa Monica. He in company with others escorted Gen. Coles Bashford from the first camp of troops stationed at Chino valley, in March 1864 to Tucson; camped at Skull Valley and *was* the man who gave the name to Skull Valley, where some skulls were found at a supposed battle ground of the Apache Mohaves and Wallapais; he has since been mining in Arizona, Nevada and California. He is a first-rate man.

Resigned at Santa Fe, New Mexico Territory, July 11, 1866.

Transferred to Company B, First Battalion of Veteran Infantry, California Volunteers.

Promoted First Sergeant, Second Lieutenant, appointed Acting Regimental Quartermaster April 1864.

Enrolled at and mustered-in as Private, Company C, 1st California Infantry, August 1861.

Alonzo M. Erwin, 1838-1868

Killed by Indians at Canada del Oro on the road between Tucson and Camp Grant.

Elected from Camp Grant as a member from Pima County **to the House of Representatives,** 5th Territorial Legislature, June 3, 1868.

Mustered-out at Fort Craig, New Mexico Territory, August 31, 1864.

Enrolled and mustered-in as Private, Company G, 1st California Infantry, August 1861.

Oscar Hutton, ca. 1830-1873

Hutton Peak, about 12 miles southwest of Globe, Globe County, is named for him.

Hutton Butte, 5 miles southeast of Point Imperial in Grand Canyon Natural Park is named for him.

Mustered-out at Santa Fe, New Mexico Territory, January 22, 1865.

Enrolled at San Francisco, Private, Company C, 1st California Cavalry, January 22, 1862.

Hiram Kennedy, ca. 1835-1877

Hiram Kennedy was enumerated at Arizona City in 1870. About 1872 he was one of the founders of Safford. He was killed from the effects of a knife in the hands of Theodore Brown with deadly intent and without proper justification at Safford October 7, 1877. His burial site is unknown.

Private Kenney served at Fort Mohave and at Camp Lincoln (La Paz), Arizona Territory, and was discharged at Drum Barracks, California, November 1, 1864.

Hiram Kennedy enrolled at Auburn, Placer County, California as Private, Company F, 4th California Infantry, October 20, 1861.

Naturalized as an American Citizen at Florence, Pinal County, December 5, 1877.

Discharged at Drum Barracks, California, February 19, 1866.

Re-enlisted as a Veteran Volunteer at Drum Barracks June 17, 1864.

Stationed at Fort Mohave from May to December 1863.

Enrolled at Forest Hill, California, in Company B, 4th California Infantry, September 12, 1861.



George T. Martin was listed as a Tucson agent for the Wells Fargo Express Company at Tucson, 1884; **Postmaster at Mohawk, Yuma County, from April 28, 1893, to August 22, 1895;** Secretary, Mohawk Canal Company, 1893; and a member of the Grand Army of the Republic. He is buried at the Los Angeles National Cemetery.

George Thomas Martin was born at Martinsburg, Berkeley County, West Virginia, November 16, 1839. He enrolled and mustered-in as Private, Company B, 2nd California Cavalry, at San Francisco, California, September 25, 1861. Private Martin was promoted Commissary Sergeant vice Jesse T. Maynard, who was discharged by reason of wounds received in action December 19, 1862. Commissary Sergeant Martin was discharged for disability, pneumonia and pleurisy, at Fort Sumner, New Mexico Territory, March 13, 1864.

William Rannels McCormick was born in Bourbon County, Kentucky, 1843. He enrolled and mustered-in as Private, Company C, 1st California Infantry, during August 1861. He was promoted Sergeant September 1 and was in charge of nine men of his company which joined the escort of the **Arizona Territorial officials at Fort Wingate, New Mexico Territory, December 20, 1862.** The officials included Richard C. McCormick, Secretary of the Territory, and Judge Joseph P. Allyn. He was a foreman at the Longfellow Mine, Copper Mountain, Clifton, Greenlee County and Justice of the Peace at Clifton. 1885-87.
