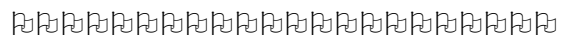
In order to meet these objectives, Ron and any other Brothers who wish, will represent the SUVCW and particularly the Brothers of Picacho Peak Camp #1.

The Department of California and the Pacific (includes camps in California, Nevada and Hawaii) with over 400 members and ten Camps has extended an invitation for us to join.

### **SIERRA VISTA "ADOPT A SCHOOL"**

*the following information about Civil War Days at Sierra Vista school is provided by Brother Ron McCreery.*

Ron has represented the Union for the last two years in his blue forage cap and regular civilian attire. This next year, he will be in full uniform of a first sergeant, Co. A., Sixth West Virginia Volunteer Infantry, a position held by his great - grandfather. He will explain the uniform, show his great-grandfather's Civil War Prayer Book, and talk about some of his relatives and the battles in which they participated. One of the seventh graders from last year, was named William Sherman--a direct descendant.

Other activities include the SCV and their Ladies Auxiliary; a campfire; "B" Troop of the 4th Cavalry Regiment (Memorial), the ROTC Drill Team and an exhibit of a Spencer repeating rifle. The school cafeteria serves hard tack, beans, applesauce and milk (no camp coffee!) for lunch.

Activities start at 9:00am and end at 2:00pm. Ron will be donating Civil War Books which will be placed in the school library.

Visitors must check in at the school office.

School directions: Take AZ 90 south from I-10 (Exit 302) through Huachuca City to the light at Fort Huachuca's east gate. Turn left onto bypass then right on N 7th St. (first traffic light). Continue on 7th St., turn left on Busby Drive (convenience store/gas on corner), then right on Lenzner Ave. The school is a few hundred yards on the right.

## FEBRUARY 12, 1809; A BIRTHDAY TO CELEBRATE

On February 12, we will be celebrating the birthday of one of the greatest of all U.S. Presidents: Abraham Lincoln. This is a special day, for without his perseverance and vision, which helped guide the United States through the Civil War, our country could very well be quite changed from what it is today. And, had he lived past the end of the Civil War, Reconstruction and all it entailed may not have been nearly as painful for our country.

How many other of our presidents were faced with such momentous pressures and decisions from the first day of their first inauguration?

“In your hands, my dissatisfied fellow countrymen, and not in mine, is the momentous issue of civil war. The government will not assail you... You have no oath registered in Heaven to destroy the government, while I have the most solemn one to preserve, protect and defend it.”

What other president, after four years of a bloody civil war with hundreds of thousands of casualties, would still have the conviction to write in his second inaugural address:

“With malice toward none; charity for all; with firmness in right, as God gives us the right to see, let us strive to finish the work we are in; to bind up the Nations wounds...”

Between these inaugural addresses was:

“Four score and seven years ago our fathers brought forth on this continent, a new nation, conceived in Liberty, and dedicated to the proposition that all men are created equal.

Now we are engaged in a great civil war, testing whether that nation, or any nation so conceived and so dedicated, can long endure...”

In spite of the events, the doubts, and the pressures placed upon him by the country, the congress, and even his own cabinet, Lincoln forged ahead to ensure that our nation, so conceived and so dedicated, came through the test and “ can long endure”. After all he had been through, he was assassinated on Good Friday, April 14, 1865, just 42 days after his second inauguration.

February 12, is a day when we should reflect on the skills, accomplishments, and life of our 16th President, Abraham Lincoln. Fly your flag on this day as a tribute to Lincoln for all he did ...and for all he could have done.
