# Sketches of history from the territorial days of Phoenix, Arizona and the John W. Owen Post No. 5

Quite a while ago I noted in a newsletter that I was going to start publishing newspaper accounts of the Grand Army of the Republic activities in Phoenix, namely those of the John W. Owens Post.

By now you probably know that the John W. Owens Post was formed on September 24, 1885, four years after the incorporation of the city of Phoenix, Arizona Territory.

You will note that initially the Post has the number 83. This was its number while part of the Department of California (Arizona did not have its own Department until 1888).

Each year the Grand Army of the Republic had its National Encampments in various cities through the country. At the end of the encampment journals were published which were many hundreds of pages long detailing encampment activities. I was fortunate to obtain copies of many of these journals and especially that of the 20<sup>th</sup> National Encampment, held in San Francisco, Ca. in 1886. This journal contained the officers and members of all the Posts in Arizona. This is a big deal since GAR records for Arizona are almost not-existent and we know have a list of some Post members. Those of the John W. Owens Post are as follows:

Sketches of history continued

The following article taken from the *Daily Phoenix Herald* relates information from 1883. This is several years before the John W. Owens Post comes into existence, but it is important because some of the players will become members of the Post and the Grand Army of the Republic was instrumental in starting Memorial Day.

May 31, 1883:

# Honoring the Memory of Our Fallen Brave.

Owing to the lateness of the call for soldiers of the war to participate in the decoration of the graves of their fallen comrades, no organized effort was made today, but a few gentlemen, mindful of the noble men who had stood by them in the rain of death, gathered together and performed the services to the best of their ability. The supply of flowers was somewhat limited, but one lady, Mrs. McDonald, responded to their request for flowers, and to her the gentlemen interested hereby wish to return their sincere thanks for her thoughtful favor. The gentlemen performing the services were: C.A. Knapp, J. M. Cotton, and Capt. W. T. Wools, Capt. J. King and Louis Gazette and the graves decorated were those of: Judge Dunham, Gustav Kauchner, Daniel Dietrich, Capt Owens, E. A. Phelps, King S. Woolsey, Judge Wilkes, Paul Handel and McNulty. It is hoped that this is but the beginning here of this beautiful and touching custom and that next year will be a more general recognition of the merits of those who in the days gone passed at the front through our nations ordeal of blood and fire.

Other than the 1883 article, there is no mention of any GAR related activities in the city of Phoenix until the January 6<sup>th</sup> article.

From this point forward, I will publish articles in chronological order in this and future newsletters.

January 6, 1886:

#### G. A. R. Installation

On last evening the officers of John W. Owen Post, 83 Grand Army of the Republic, were installed for the ensuing term as follows:

C.A [H]. Knapp, P.C.; R.J. Cartwrite, J. V.; John King, Quartermaster; J. E. Wharton, Surgeon; L. A. Tiffany, Officer of the Day; H. B. Lighthizer, Chaplain; J. B. Creamer, Adjutant; John Mullin, Officer of the Guard; Anthony Hagerups, Sgt. Major.

There was a large attendance and a good time. The boys talk uniform very strongly and think that Memorial Day they will have a membership of at least fifty which is a lively growth for a young post.

Dr. J. M. Hurley a visiting brother from a Missouri post was present and participates in the ceremonies of the evening

#### Memorial Day.

The Committee of Arrangements, consisting of Comrades Wharton, Cramer, Lighthizer, Coats and Ed Schwartz, Chairman of the Committee met at 8 o'clock on the evening of the 15<sup>th</sup> of May, and after hearing reports of the sub-Committees, adopted the following:

Services on the Plaza will commence at 7:30 when all are invited to attend.

June 1, 1886:

#### **The Memorial Services**

John W. Owens Post No 83 Grand Army of the Republic did well yesterday in so successfully inaugurating here, the touching and beautiful custom of strewing the graves of the dead soldiers of the civil war with flowers.

At noon, as announced, the doors of all business houses were closed and at 3:30 a large number of our citizens and of the Sunday School children had

congregated about the plaza. At 4 o'clock promptly, the members of John W. Owens Post accompanied by Veterans of the Mexican war and Confederate soldiers marched from their hall and took up a position on Washington street opposite the plaza where the procession formed and moved down Washington street to the old cemetery where the dead soldiers lie. The procession was a large one consisting, after the Veterans of the Mexican war, the G.A.R. boys and the Confederate soldiers, of a considerable line of Sunday school children and a line of citizens in carriages that stretched back for several blocks. The ceremony of depositing the garlands of flowers upon the graves over, the Post and guests returned to the city and disbanded till 7:30 o'clock in the evening when they reassembled on the plaza to listen to the orations of the occasions by Judge Deforest Porter and Hon. Jos. Campbell. The evening service opened by an invocation by the Rev. Calfee, then the song "Tenting to-night on the Old Camp Ground" was beautifully rendered by a double quartette of male voices after which Judge Porter proceeded to deliver a short, impressive and most appropriate address in which were many touching and very eloquent passages.

Maj. Ed. Schwartz then favored the audience with the song "Mother Kiss Me in My Dreams," sang in his firm baritone voice with fine effect. The Hon. Jos. Campbell then followed with an address replete with beautiful pictures of thought and touching allusions fully maintaining his reputation for eloquent and forcible oratory.

The assembly was then dismissed with the singing of "America" by the quartette. The entire exercises occupied but little over an hour and the audience dispersed with a general desire for more rather than with a feeling that they had had too much, a little point that the Grand Army boys showed great discretion in making while preparing their programme.

The observance of the day was a credit to the Grand Army boys and our little city. If more such days could be indulged, where party and sectional strife could find no place and where selfishness gives way, for a few moments to the nobler impulses of generosity, the refining, ennobling influence would be felt in the more rugged walks of society.

OK, this ends the first installment of my newspaper articles. For those who read about our GAR marker ceremony, or were present, you will notice the name of Major Ed Schwartz.

Also notice the first major activity of the post was the inauguration of Memorial Day for the city of Phoenix.

You may also notice some misspellings or other grammatical errors; for once they are not mine, but those contained in the original articles.

#### The Early Days of Picacho Peak Camp No. 1

Excerpt from a speech that Larry Fuller, Camp founder and first Camp commander, gave on Nov. 15, 2008

"In the latter days of 1994, while perusing a copy of the American legion magazine, I noticed an advertisement for an organization called the Sons of Union Veterans of the Civil War. This piqued my curiosity since my greatgrandfather, Major William Plumb, was an officer in the U.S. Army during that war.

There was contact information so I called and talked to a gentleman in Detroit and, after asking some questions about the organization, I joined as a member-at-large on January 18, 1995. During our conversation I asked him if there was a Camp in Arizona and he said, 'No! Do you want to start one?' I asked him how many members it would take and he replied 6 to start a Provisional Camp and 15 to have a Chartered Camp. In pursuing the possibility of forming a Camp in Phoenix, I found out from National that there were 15 members at large in our area and I got their names and addresses and wrote to them about becoming a camp. The feedback from the letters was positive so I continued my quest.

I called a meeting and 6 people showed up—we became a Provisional Camp. Allen Murphy, a retired minister, visited me at my home and told me his Great Grandfather was a chaplain in the Civil War—he became our Camp Chaplain.

Within 30 days after more letters, phone calls, and net working, I called another meeting and 17 prospective members attended. We now had enough members for a full-fledged, bona fide, chartered Camp! We named it Picacho Peak Camp—a no brainier since it was the location of the only Civil War battle in Arizona.

I served a commander, Dan Zwiener from Tucson was the secretary and John Coon was the treasurer. My job was to secure a meeting place, schedule programs and preside at meetings, among other duties that may arise.

We had an all-volunteer Camp with group inspiration and enthusiasm second to none that thrust us into the Camp we are today!

After the Camp was established, we had repeated requests from National for the submittal of certain forms and we tried without success to ascertain what forms they wanted and who was to receive them. This ping pong game was getting frustrating, so I took the bull by the horns, called National and found out what forms were required and their due date.

I served as Commander for 8 years by acclimation. One major item that I was instrumental in changing was the procedure for verifying background information to support membership. This meant the verifications could be done on a local level instead of submitting reams of paper with each application sent to National."

In closing, I would like to suggest that our Camp Council institute a procedure to make phone calls to all members 2 weeks before a meeting to increase attendance and camaraderie.
