**Program speaker:** We were pleased to have Brother Bill Hearter Jr. M.D. give an outstanding presentation about his Civil War ancestor Captain Henry Waltz Smyser. Brother Bill was dressed in uniform and had Captain Smyser's Civil War sword at the meeting. Bill followed Smyser's activities during the war as an enlisted soldier and officer throughout the many battles. He then talked about his post-Civil War life. Here are some of the highlights of his talk about his ancestor:

Born- 1839 near York, PA. On family farm since Revolution; enlisted- 1861, Company E, 107th PA. Infantry; 1862- promoted to Corporal for 'bravery" after 2nd Bull run; 1862 Antietam- shot through left forearm when carrying unit flag as Color Guard Sgt.; 1863 Recruitment Sgt in SE Pennsylvania while healing; July 1-3 1863- Gettysburg, at the "stone wall" for Pickett's Charge; 1864- Battle of the Wilderness, Fredericksburg; captain of unit by March 1865; 1865- Appomattox, at surrender, as adjutant to Col. McCoy: late 1865-1866- kept his Conestoga wagon and chests from War; shipped freight from Baltimore roundtrip to Shippensburg, PA. (112 miles) WEEKLY; 1866- elopes with the daughter (Abigail Elmira) of the Hotel Owner, Mary Mateer, at friend Josephine's wedding; 1871- starts work with PRR (PA. Railroad) January, 1914- retires from PRR; dies 4 days later as his wife predicted.

#### General R. H. G. Minty Camp No 2,

On December 8, 2014, authorization to form the General R. H. G. Minty Camp No. 2, at Tucson, Arizona, was received from SUVCW National Secretary Alan Russ. This new Camp will serve those who live in southern Arizona and the Camp Organizer is Brother John Conrad.

Brother Conrad reports as follows:

Jerry Bloom and I visited Tucson on November 8 to explore a Southern Arizona Camp. Brother Brian Estes was able to join us for lunch and a detailed discussion of the new camp and what is involved in forming it. Brother Brian volunteered to serve as the new camp's Secretary-Treasurer!

Based on the interest of Brother Estes, and the conversations I had with several Southern Arizona brothers prior to the lunch, we feel there is enough interest to go forward with the camp! I submitted Form 51 to National, which requests permission to formally organize a camp (which it has). We are now able to meet again, transfer current brothers to the new camp, recruit new brothers, elect officers, and get going.

The two officers we MUST have are the Commander and the Secretary Treasurer. Brother Brian has solved half that challenge! Now, who will volunteer to serve as Camp Commander? The other normal elected positions are Senior Vice Commander (serves in the Commander's absence and typically is in charge of communication), Junior Vice Commander (helps recruit and process new members), and Camp Council (up to 3 brothers who advise the elected officers and audit the financial records once a year). Volunteers for any of these offices are encouraged! We also can have the Camp Commander appoint other officers, such as the Sergeant at Arms, Chaplain, etc.

In preparing the paperwork for Form 51, I had to provide a Camp name. Camp Historian David Swanson, through his thorough historical research, discovered that there was a Sons of Veterans Camp in Tucson around 1902 named the General R. H. G. Minty Camp No. 11. So we felt it was only fitting that our new Southern Arizona Camp carry on that historical tradition and name the camp for Minty.

So who was this guy?

Robert Horatio George Minty was born in Ireland December 4, 1831. He was commissioned as Major of the 2<sup>nd</sup> Michigan Volunteer Cavalry on October 2, 1861, but held that duty for only a month before he was transferred to the 3<sup>rd</sup> Michigan Volunteer Cavalry and promoted to Lieutenant Colonel. He was challenged to form another regiment, and so formed the 4<sup>th</sup> Michigan Volunteer Cavalry in March 1862, and promoted Colonel. The 4<sup>th</sup> fought in Kentucky, Tennessee, Georgia, and the Carolinas, seeing particular action at Chickamauga and Atlanta. Minty was brevetted Brigadier General, US Volunteers and Major General, US Volunteers on March 13, 1865 for "gallant and meritorious services during the war. Men under his command captured Confederate President Jefferson Davis on May 9, 1865.

After the war, Minty became a successful railroad executive, which led him to . . . Arizona! He formed a GAR post in Jerome before moving to Tucson and becoming Commander of the Negley Post No. 1. He must have made an impression in Tucson to have the Sons camp named after him. Minty died in Jerome on August 24, 1906 and is buried in Ogden Utah, where other family members had previously been buried. [See page 6 for more information about the general and Jerome.]

Why the Grant Camp name? Well, the Camp was organized in Flagstaff in January 1889, and as reported in the January 12, 1889 edition of the *Arizona Champion*: "The Sons of veterans organized in Flagstaff this week and elected the following officers: Capt. F. M. Ramsey; 1<sup>st</sup> Lieutenant, Harry Hoxworth; 2<sup>nd</sup> Lieutenant George Morgan. They will be installed tonight with the G.A.R. and the Women's Relief Corps."

The name of the Camp did not appear in the paper until March 1, 1890, in a column noting the passing of Grant Camp Brother Elmer C. Hoxworth (see page 5).

## National Restoration Project—Dr. Benjamin Franklin Stephenson's Gravesite [Petersburg, Illinois]

GENERAL ORDER NO. 6 SERIES 2014-2015 SONS OF UNION VETERANS OF THE CIVIL WAR

Stephenson Memorial Plaza Project

By the authority vested in me as Commander-in-Chief of the Sons of Union Veterans of the Civil War, the National Constitution and Regulations, and National Policies, it is hereby ordered as follows:

Section 1: Benjamin F. Stephenson, a medical doctor from Springfield, Illinois who had served as Surgeon in the 14th Illinois Infantry during the Civil War, had the idea that an association of Union veterans should exist in order to provide for the mutual benefit of its members and for their widows and orphans. Along with a small group of friends, he devised the concept of the Grand Army of the Republic (GAR) in the spring of 1866.

Section 2: Although Dr. Stephenson served as the provisional Commander-in-Chief of the GAR when it was founded, he was never officially elected Commander-in-Chief. However, his devotion to the organization never ceased, often at the expense of his own personal life. He died in 1871 at the age of just 47 years.

Section 3: Without Dr. Stephenson's vision and efforts the GAR would not have come into being. Likewise, without the GAR, the Allied Orders of the GAR could not exist. The Allied Orders owe their very existence to Dr. Stephenson and it is therefore appropriate that his memory should be fittingly honored by these organizations.

Section 4: The SUVCW's Department of Illinois is spearheading an effort to improve and beautify Dr. Stevenson's final resting place in the Rose Hill Cemetery in Petersburg, Illinois. The enhanced area will be known as the "Stephenson Memorial Plaza" and will provide an area where people can gather, pay respects, and contemplate Dr. Stephenson and his contributions. The goal is to have this project completed by 2016, in time to celebrate the sesquicentennial of GAR's formation.

Section 5: All members of the SUVCW and the other Allied Orders of the GAR are encouraged to contribute toward fundraising efforts to help ensure that this worthy project comes to fruition. Donations of any amount are appreciated. Memorial pavers and benches are being offered for sale for larger donations.

The City of Petersburg is completely behind this project and donations are tax deductible.

The foregoing General Order is proclaimed this 20th day of October in the year of our Lord two thousand fourteen, and of the Independence of the United States of America the two hundred thirty-ninth, in the City of Gilroy, County of Santa Clara, State of California.

## Funeral of Elmer C. Hoxworth, Camp Grant No. 1, Sons of Veterans

*Arizona Champion* (Flagstaff, Arizona), March 1, 1890:

LAID TO REST

The Funeral of Elmer C. Hoxworth Last Wednesday Moring

Monday morning our people were pained to learn, although all had been expecting it, that Elmer was dead and that his soul had taken its flight and gone before God Almighty to receive its last resting place.

Elmer C. Hoxworth was born September 14<sup>th</sup> in the year 1871, and was 18 years of age. He had been suffering from the effects of an injured leg, which injuries he received some three or four weeks previous while chopping wood. A piece of steel from a hammer which he used to drive the sledge breaking off and entering his right leg at the thigh. He lost considerable

blood at the time and became very weak. His condition did not better any to speak of and on the 14<sup>th</sup> his physician, Dr. P. G. Cornish, decided that amputation would be necessary and on the afternoon of that day, assisted by Dr. D. J. Bransen, the operation was performed. He seemed to get better for a time, but on last Friday he reached the turning point, and on Monday morning about 4:30 o'clock, he died.

The funeral took place from the M. E. Church at 11:00 o'clock a.m., Camp Grant No. 1 Sons of Veterans having charge, although it was a very stormy and disagreeable day the remains were followed to the Cemetery by a large number of people who went to pay their last respects to their young friend. Rev. G. H. Gill preached the funeral sermon, and made very fitting remarks for the occasion. The services at the grave were conducted by the Sons of Veterans.

At special meeting of Camp Grant No. 1, S of V, held last Wednesday night, the following resolutions were unanimously adopted:

#### RESOLUTIONS OF CONDOLENCE

It has pleased Almighty God to remove from our midst, Elmer Hoxworth a brother of this camp whose death took place on Monday, February 24, 1890. Now as a fitting memory to our deceased brother, be it

RESOLVED, That the officers and members of Grant Camp No. 1, Sons of Veterans, Division of Colorado, attend the funeral in a body,

RESOLVED, That our charter be draped in mourning for a period of thirty days,

RESOLVED, That in the death of our brother, this camp looses one of our best members, and Flagstaff one of its brightest young men,

RESOLVED, That we extend our sympathy to the bereaved parents and relatives of our late brother, and that they be presented with a copy of these resolutions.

# General R. H. G. Minty and the Jerome, Arizona George H. Thomas Post No. 11, GAR

THE ARIZONA REPUBLICAN Monday, May 29 1899.

"The preliminary steps looking to organization of a Grand Army post are progressing favorably and installation will probably take place within as couple of weeks. A large number of old soldiers live in Jerome and vicinity, many of them already members of the

Grand Army of the Republic. The following will be the charter members of Jerome's new post, which will be officially styled the George H. Thomas post No. 11. Department of Arizona, Grand Army of the Republic. viz: General R. H. G. Minty, J. T. Whedon, John Kirwaggen, W. James Barton, N. S. Hitchcock, J. W. Selsor, L. P. Nash, S. W. Landon, C. S. Smith, James Burke, George Thompson, Charles O'Neill, L. Holinwager, J. Shoppertrout, George Bagnall, N. K. Burkes, W. Tietge, F. Fisher, and H. L. Stevens—ten members are required in an organization under departmental rules the indications of a large, flourishing post at Jerome in the near future are very flattering indeed. There at present nine G.A.R. posts in Arizona. There was formally ten, but one at Bisbee formally disbanded. Department Commander G. Broughton of Prescott will install the Jerome post when all is in Readiness The formation of this post is due almost entirely to the efforts of General R. H. G. Minty, auditor and freight and passenger agent of the United Verde & Pacific railway. General Minty issued a call which resulted in drawing together a number of old soldiers on the 20th of last month. But for the fire everything now would be in running order. Genera volunteer of the civil war, and his record is part of the history of that great conflict. He entered the Union army from the state of Michigan early in the fight as a major of the Second Michigan cavalry (afterwards Phil Sheridan's regiment): was promoted to be lieutenant colonel of the Third: then to be colonel of the Forth: then brigadier-general and finally brevet major and as such was mustered out at the close of the war. The general is now well advanced in years, but hale and hearty, with a naturally keen interest in all military affairs, and a great affection for the Grand Army of the Republic. He lives at Jerome in a handsome residence, surrounded by his large, cultured family, including four generations, and is the center of a refined and accomplished social circle. Prior to his advent in Jerome General Minty was for many years a resident of Ogden. Utah, where he owns a beautiful home, and was prominently mentioned as a likely candidate for United States marshall. But, like that other honored warrior, albeit of the sea, George Dewey, politics is not in the general's line, while railroads are to him an old story. There is much local interest in the new G. its prime mover in its formation is the recipient of congratulations from all quarters."

Editor's note: General Minty's house in Jerome is still standing and occupied. The fire mentioned in the article burned down multiple saloons and restaurants and was one of four devastating fires in the town's history. And finally, the post, in spite of the "indications of a large, flourishing post at Jerome in he near future" was only in existence for fourteen months.
