GENERAL ORDER - 07 Establishment of the Department of the Southwest

On November 17, 2015. I received a request from the following Camps to form a Department.

- Picacho Peake Camp No. 1 of Phoenix, Arizona
- General R. H. G. Minty Camp No. 2 of Tucson, Arizona
- General U. S. Grant Camp No. 3 of Flagstaff, Arizona

In accordance with National Regulations, Chapter II, Article I, Section 7, the petition of said Camps is approved and the Department of the Southwest is hereby established and shall be composed of the states of New Mexico and Arizona. The Department of Texas is commended for its past stewardship of the state of New Mexico. The Date of Rank for the Department of the Southwest is: December 3, 2015.

The Department of the Southwest is hereby authorized to hold a Special Department Encampment to complete the organization of the Department, including the election of Officers, Delegates to the National Encampment, and the adoption of Department By-Laws.

Ordered this 3rd day of December, 2015, in the Town of East Berlin, Pennsylvania.

Petition to form the Department of the Southwest



Nevada becomes the 36th state

On October 31, 1864, Nevada became the 36th state in the United States. So, what's the big deal?

Our country was in the throes of a civil war when 11 states attempted to secede (had they been successful Nevada would have been the 25th state), but beyond that look at the Civil War politics involved and the implications of the telegraph which was invented 20 years earlier.

The following information is taken from History.com/this day in history.

"On [October 31] 1864, anxious to have support of the Republican-dominated Nevada Territory for President Abraham Lincoln's reelection, the U.S. Congress quickly admits Nevada as the 36th state in the Union.

"In 1864, Nevada had only 40,000 inhabitants, considerably short of the 60,000 normally required for statehood. But the 1859 discovery of the incredibly large and rich silver deposits at Virginia City had rapidly made the region one of the most important and wealthy in the West.

"The decisive factor in easing the path to Nevada's statehood was President Lincoln's proposed 13th Amendment banning slavery. Throughout his administration Lincoln had appointed territorial officials in Nevada who were strong Republicans, and he knew he could count on the congressmen and citizens of a new state of Nevada to support him in the coming presidential election and to vote for his proposed amendment. Since time was so short, the Nevada constitutional delegation sent the longest telegram on record up to that time to Washington, D.C., containing the entire text of the proposed state

constitution and costing the then astronomical sum of \$3,416.77.

"Their speedy actions paid off with quick congressional approval of statehood and the new state of Nevada did indeed provide strong support for Lincoln. On January 31, 1865, Congress approved the 13th Amendment to the U.S. Constitution banning slavery."

What about the telegraph? In 1844 when Samuel Morse tapped out the following message "What Hath God Wrought?" the seismic shift in worldwide communications was likened to the invention of the computer.

"For thousands of years messages had been limited by the speed with which messengers could travel and the distance at which eyes could see signals such as flags or smoke. Neither Alexander the Great nor Benjamin Franklin (America's first postmaster general) two thousand years later knew anything faster than a galloping horse." (What Hath God Wrought, by Daniel Walker Howe.)
