Minutes of the May 14, 2012, Camp meeting:

Location: Hometown Buffet 1312 N. Scottsdale Rd., Scottsdale, Az

Camp Commander David Swanson called the meeting to order at noon. There were 25 Brothers and guests in attendance.

Officer's reports:

Camp Commander Swanson gave a brief sketch of the upcoming 2012 Department and National Encampment to be held in Los Angeles and since we have delegate positions still available, asked if there was any interest.

Senior Vice Commander:

Brother John Conrad and Brother Jan Huber discussed the case of Union Civil War and later Buffalo Solder Ambrose Skinner. Brother Huber

related that over a year ago he discovered that there is a black Union Civil War soldier buried in Greenwood Memory Lawn in Phoenix who does not have a headstone. He remained in the army after the Civil War and became a Buffalo Soldier. He sent the information to the local Buffalo Soldier reenactment unit thinking that they would take the ball and run with it as far as getting an appropriate headstone for him. Nothing has been done—possibly money is the issue. One can get a military headstone for free from the VA but Greenwood apparently charges \$700 to put it in place. He later gave a program at the Black Family Genealogy & History Society meeting and found out that this organization knows about the situation with Ambrose Skinner and is beginning to plan on organizing an effort to raise the necessary amount of money. Jan recently contacted the Society but after several attempts has not received any information. Jan suggested that our Camp take over the project and funding.

Senior Vice Commander John Conrad earlier indicated that he would match the Camp funding, dollar for dollar, up to \$350.00.

A motion was approved by the Camp to spend \$350.00 for this project and Brother Conrad agreed to take over this endeavor.

Ambrose Skinner was born in North Carolina into slavery. Joined the US Army Colored Troops in 1863, then the Buffalo Soldiers after the war. He lived most of his life in Maricopa County, where he died, leaving a widow and 4 children.

--Update--

Brother Huber reports that the Greenwood Cemetery agreed to set the headstone for free—more on this topic as things progress.

Graves Registration:

Brother Jan Huber reported that since the last meeting he has registered one grave, however, this one was quite unusual. His Confederate counterpart sent him all of the information regarding a Confederate grave marker in the Mesa City Cemetery. In doing the

research for his graves registration he discovered that the soldier, James M. Selby, was a Yankee! He was in the 1st Regiment Alabama and Tennessee Independent Vidette Cavalry. A Vidette is a mounted sentinel stationed in advance of pickets or outposts of an army. He was born in Alabama and this is where he enlisted. The poor guy is probably still spinning in his grave. He risked his neck by joining a Yankee outfit and gets buried with a Confederate grave marker!

Secretary/Treasurer:

Brother Jerry Bloom gave a comprehensive report on our Camp's financial condition and our current membership level. We currently have 66 Brothers and two Junior members.

The Studebaker Corporation and the Civil War

I think most in our Camp have heard about the Studebaker (oh, come on—you have too). Anyway a while ago I received some information from History.com about the Studebaker Corporation that was quite interesting.

> The roots of the Studebaker Corporation date back to 1852, when siblings Henry and Clement Studebaker opened a blacksmith shop in South Bend, Indiana. Studebaker eventually became a leading manufacturer of horse-drawn wagons and supplied the U.S. Army with wagons during the Civil War. Around the turn of the century, Studebaker joined America's burgeoning auto industry, launching an electric car in 1902 and a gas-powered vehicle two years later that was marketed under the name Studebaker-Garford. After partnering with other automakers, Studebaker began selling gas-powered cars under its own name in 1913, while continuing to make wagons until 1920.

History of the Grand Army of the Republic in Arizona and the Arizona State Library, Archives and Public Records

Over the years I have compiled a history of the GAR in Arizona (sketchy as it is) with help from the Library of Congress and the Arizona Historical Society.

Historical Sketch of the John W. Owens Post No. 5, Phoenix, Az

Here is a continuation of articles regarding the John W. Owens Post No. 5 GAR of Phoenix from its inception in September 1885. This "historical sketch" includes a glimpse of the Post, the Department of Arizona GAR, the city of Phoenix and the territory and state of Arizona, taken solely from published Phoenix newspaper accounts.

In this account (from the *Daily Phoenix Herald*) we read about Memorial Day preparations in Phoenix, Ariz., in 1888:

"Monday, May 29, 1888

G. A. R. Programme for Memorial Day

The following is the order of arrangements for the observance of Memorial Day, Wednesday, May 30th, 1888:

The parade, under the direction of Allen T. Bird, Marshall, assisted by Frank D. Wells, and L. Neustatter, Aids, will form on Washington street, with the right resting on Montezuma street, at 4 o'clock p.m. sharp, in the following order:

1. Advance Guard, Marshall Wm. Blankenship, and assistants Frank Cox and Frank Baxter, mounted.

2. Band

3. Mexican Veterans

4. Junior Vice Department Commander, Edward Schwartz, and Department Staff, mounted.

5. John A. Logan Post No 7, G.A.R., F. S. Earl, Post Commander.

6. John W. Owens Post No. 5, G.A.R. Joseph B. Creamer, Commander.

7. Old soldiers.

8. Patriotic Order Sons of America, Tempe.

9. Orator of the Day, Col. James A.

Zabriskie.

10. Mayor and Common Council in carriages.

11. Women's Relief Corps—Flower committee in carriages.

12. Independent Order of Odd Fellows Canton Arizona, No. 1, Patriarchs Militant, N. A. Morford, Commandant.

Floral Encampment No. 2 Phoenix Lodge No 2, Robert Kern, N. G. 13. Knights of Pythias, Phoenix Lodge No. 2 Webster Street, Chancellor Commander,

14. Independent Order of Good Templars,

15. Fire Department, J. B. Long, assistant chief engineer.

16. Public School and Sunday school children.

17. Citizens in carriages.

18. Rear Guard.

The procession will move promptly at 4:30 o'clock p.m., and will march west along Washington street to Mojave, thence to Monroe, east on Monroe street to Pima, thence to Washington, and on Washington street to the City Hall Plaza, where the Memorial Ceremony will be conducted, and the people dismissed.

In the evening there will be given a public ceremonial at the Opera House, and an oration by Col. Jas. A. Zabriskie, of Tucson.

Tuesday, May 29, 1888:

Local Lines:

The G. A. R. boys will have a great day tomorrow. Businesses generally will close up and all societies of the city will turn out. The parade will not extend to the city cemetery this year owing to the distance and warm weather. The display promises to be the grandest the city has ever seen.

Col. J. A. Zabriskie, the orator of the day for tomorrow with his wife and family arrived at the Lemon hotel this morning. The Colonel will deliver his oration in the Opera House tomorrow evening, and we do not need to say to Arizonans who have heard him that he is equal to the occasion."
