### Department by-laws revised

Revisions to the Department by-laws were unanimously approved. The revisions were made in response to General Order No 18, issued by then CinC Mark Day on February 6, 2018, which contained mandatory information that had to be inserted in Department and Camp bylaws throughout the Order to be in compliance with IRS regulations.

# Department approves amendment to the SUVCW National Constitution

General Order No. 7, issued on December 5, 2018, by Commander-in-Chief Donald W. Shaw, directed that all Department Encampments in 2019 vote on a proposed amendment to the SUVCW National Constitution.

As an overview, the proposed amendment states in part: "Article V, Section 2b. If the Commander-in-Chief is of the opinion that an action of the last proceeding any National Encampment is in violation of or in conflict with our Congressional Charter, and/or the Constitution, and/or National Regulations, and/or United States Law, and/or any State's Law, he may propose such General order(s) to delay implementation of such action or suspend such action if previously implemented, until such time as the violation or conflict can be corrected. . . . This proposal clarifies the Commander-in-Chief's authority to take action to suspend or delay the implementation of any action taken by any National Encampment rather than just the last National Encampment and includes State Laws as well as United States Laws."

The Department of the Southwest unanimously voted for approval of the proposed amendment (which must be favorably acted upon and ratified by at least 50% of all Departments for passage).

### DEPARTMENT ORDERS

Department of the Southwest Sons of Union Veterans of the Civil War GENERAL ORDER 01 (SERIES 2019-2020) Change of Command and Department Activities

By the authority vested in me as Commander of the Department of the Southwest of the Sons of Union Veterans of the Civil War, the National Constitution and Regulations, the National policies, and the Department Bylaws, the following is ordered:

- 1. At Tucson, Arizona, on March 30, 2019, the Delegates to the First Department Encampment elected me to the highest office in the Department. I am honored to serve my Brothers in this capacity, and will do all in my power to promote the success and growth of the Department and its activities.
- 2. Headquarters of the Commander is hereby established at 4323 N. 28<sup>th</sup> Way, Phoenix, Arizona 85016. All correspondence for the Commander may be posted to that address. Email can be sent to me at: Jerrybloom @com and my phone number is 602-955-3091.
- 3. Correspondence concerning Department or Camp activities, finances, reports, and membership should be directed to Department Secretary-Treasurer Dale E. Enlow, 7723 E. Treeline, Hackberry, AZ 86411, Phone: 928-715-5109, Email: dale enlow@hotmail.com. 4. As heirs to the Grand Army of the Republic, all of the Brothers of the SUVCW swore to protect May 30<sup>th</sup> as Memorial Day—since this was the day set aside by those Comrades who saved our Union. I encourage the Camps to have some sort of ceremony on this day but if not possible Brothers should at least fly the flag of the United States in tribute. Additionally, I strongly encourage Camps to participate in the National Memorial Day ceremony to be held on Monday May 27, 2019, in their local communities. Remember, Memorial Day honors all of those who "gave their last full measure of devotion" in saving our country during any war or conflict.
- 5. All of the Camps should actively participate in presenting SUVCW flag certificates to those individuals and companies who patriotically display the grand flag of the United States. Camps should keep a record of their actions in this regard and notify the editor of the Department newsletter.

  6. Monument Committee: A committee comprised of Brothers Jeff Burgess (chairman), John Conrad

PDC, and others as appropriate has been formed with the purpose of getting a monument to the California Column placed at the Wesley Bolin Memorial Plaza in Phoenix or other appropriate site. While we have had some headwinds I express my confidence in the committee and its purpose.

7. I thank all of the Brothers of the Department of the Southwest and its Camps for their membership since without it we would not exist! I encourage Brothers to actively support their Department and Camps by volunteering for programs and the various officer position opportunities.

### From the Department ROTC Coordinator

JROTC Coordinator Bob Archibald

I have distributed JROTC/ROTC certificates and medals to 24 high schools and 4 University units. The breakdown by Camps is as follow: CAMP #1 -14; CAMP #2 - 2; and Camp #3 -12. Camp #1 numbers are high because we have Brother Dan Huskisson, who alone presents (6-7) SUVCW high schools awards in conjunction with another organization he represents. Camp #2 is now limited but has many opportunities to expand next year. Camp #3 includes 4 University ROTC units at Embrey-Riddle and NAU. It also covers 4 high schools on the Navajo/Hopi reservations and one in New Mexico.

I am in the final steps in obtaining presentation dates and a few more presenters. The award dates run from mid April to early May.

### Proposed Union memorial at Wesley Bolin Plaza in Phoenix stalls in headwinds of Confederate monument controversy

Despite the best efforts of our Monument Committee to get a bill introduced in the Arizona Legislature authorizing the placement of a memorial to Union soldiers of the California Column at the Wesley Bolin Plaza in Phoenix, the apparent fear of stoking any controversy regarding the existing Confederate monuments in the state is having a stifling effect.

Two years ago a bill was written by a state senator (but not acted on), last year (election year) nobody would touch it, but this year there was a glimmer of hope that something might actually get done by the legislature until somebody must have uttered the "C" word.

The committee will continue in its efforts to get a memorial to the Union soldiers who protected the territory of Arizona during the Civil War—they deserve it!

### In Memorial

### February 16, 2019, Camp meeting

The February 16, 2019, Camp meeting was opened by Camp Commander Jeff Burgess at noon with Sisters of the Picacho Peak Auxiliary No. 1 and guests in attendance.

### Officer Reports

Camp Secretary/Treasurer Jerry Bloom reported that we had a healthy balance in our bank account, and

that he was busy collecting 2019 membership dues from those brothers that hadn't paid yet, as the deadline was fast approaching. He also explained that he needed a replacement for his Assistant Secretary/Treasurer, especially to help with Excel spreadsheets.

Department ROTC Coordinator Bob Archibald gave a report on the Department's robust ROTC program.

Camp Chaplain Jim Heller provided a biography of Camp Patriotic Instructor, Allen Nash, who died on January 22, 2019. He asked for a moment of silence in remembrance of Brother Nash.

Department Signals Officer Jeff Burgess reported that the Department's website had already generated email inquiries from 6 potential new members this year. Also, the page on the website that's dedicated to our Union soldier memorial project has been redesigned to provide more online resources. Related to this, a Facebook page for the SUVCW Department of the Southwest was created to help generate traffic to the website, and to help promote the Union soldier memorial project. It was explained that no SUVCW business would be conducted on the new Facebook page, but that its purpose was to take advantage of the free advertising provided by Facebook. (It was noted that the national SUVCW, the Arizona DUVCW, the Gen. U.S. Grant Camp #3, and the Picacho Peak Camp #1 Auxiliary also have Facebook pages.)

### **Old Business**

The Department Encampment will be held on Saturday, March 30, 9am-2pm, at the Sabbar Shrine Temple, 450 S Tucson Blvd, Tucson, AZ. The proposed revisions to the Department's bylaws, recently distributed by David Swanson, will be considered.

### New Business

A volunteer was requested to replace the Camp's Patriotic Instructor Allen Nash.

Verna Griffith of the Picacho Peak Camp #1 Auxiliary asked for the brothers' help in getting their group some new members.

Camp Council Kenneth Hooker suggested that the Camp get some business cards that could be used for Camp business, such as membership contacts and the Union soldier memorial project. It was also suggested that the Department print a foldable, color brochure for distribution at public events. Brother Hooker said he would follow up on these ideas.

### Featured Speaker

Department Civil War Memorials Office John Conrad described our efforts to support a bill in the 2019 Arizona Legislature to authorize a Union soldier monument on the Wesley Bolin Memorial Plaza at the Arizona state capitol. He explained that some of our officers met with state Sen. Sean Bowie (D) on January 3, who supported the bill but advised us that we needed a Republican sponsor, since Republicans controlled the Legislature. There was a subsequent meeting House Speaker Russell Bowers (R) on January 22, wherein he indicated he supported the idea, and said he would "shop it around." But we never heard anything more from him.

On February 5 some of our officers met with Senator Michelle Ugenti-Rita (R) in her office. She promised to support of the bill, even though the deadline for introduction of new bills had been the day before. On February 8, she notified us that she would use a strike-all amendment for SB 1150 at the Senate Commerce Committee hearing on February 14 in order to replace its language with language authorizing the memorial. On February 13 she notified us that the President of the Senate Karen Fann (R) had blocked her strike and replace because she felt that some Democrats would try to use it to remove the plaza's existing Confederate monument. This was despite the fact that we told her the SUVCW has an official policy of not getting involved in Confederate monument controversies. Sen. Ugenti-Rita promised, however, to try another tactic, although we haven't heard back from her since then.

John explained how the Department needed to start working to educate all legislators about our effort, especially to generate bipartisan support. He suggested that the argument for the monument should be characterized as A Memorial to the Founding of Arizona, as the Territory of Arizona was the Union's response to the Confederate occupation of the region, and this approach would have a broader appeal. John and Department Graves Registration Officer David Jackson provided some supporting printed resources, and digital versions have been posted to the project's page on our website: https://suvcw-

### **April 13 2019. Camp Meeting Information**

The Camp met at The Kettle Restaurant in Tucson with 10 in attendance, including a past Department Commander, Department Commander, and 1 spouse.

Commander Haley opened the camp meeting. Department Commander Bloom was recognized and talked briefly about a couple of program ideas and contacts for upcoming meetings. He also told of an upcoming 2021 World Canal Conference to be held in Maryland and would have programs on the C&O Canal that was a key point early in the Civil War.

A proclamation is being worked on for Arizona modeled after one the Department of Indiana has done that would honor Civil War Veterans Memorial Day. The hope is to get the Governor to sign and publish it as a formal proclamation.

Minutes from January's meeting were read and approved as well as the treasurer's report.

### Old business:

May 25 was set as the day to place flags on solder's graves at Evergreen Cemetery. A reminder e-mail will be sent out. The 27<sup>th</sup> after the parade will be pick up day for the flags.

### New business:

The Memorial Day Parade at Tucson Estates. Meet by 7:00 AM at the hardware store off Kinney road. Form up of the parade units will be 7-8 with the parade stepping off at 8:00 AM on the 27<sup>th</sup>. We will be participating with members of the 1<sup>st</sup> New Mexico Company B again this year.

Next meeting will be July 20, at 1:00 PM at the Kettle Restaurant.

Commander Haley gave a talk on The Navy and how there were submarines and 'aircraft carriers' in the Civil War! The Commander pointed out that there were approximately 20 submarines between the two sides. The most famous of which was the Hunley. This sub claimed 3 crews, 5 of the first 8-man crew, 8 of the second (including the inventor) and 8 of the third crew as well as the ship itself with the sinking of the USS Housatonic off Charleston harbor.

He told of the first 'aircraft' being balloons used to spot enemy locations and movements and how there were two schools of thought on their use. Free flight and tethered. Tethered being most effective. The first 'aircraft carriers' were used in May of 1862 when a balloon was anchored to a coal barge and moved up and down the river for spotting. This first ship was named the 'General Washington Park Custis'.

Commander Hadley also touch on how some of the Navy terms, such as 'port' and 'starboard'; rum and grog; and "Navy Proof' came into use.

The meeting was closed by Commander Haley at 2:00 PM.


The "Chase" involved Union Army volunteers who commandeered a train with a locomotive named "The General" in Atlanta on April 12, 1862, and the plan was to do as much damage to the railroad as possible on its way to Chattanooga, Tenn—but things went terribly wrong. They were pursued by the Confederates with the locomotive (and train) named "The Texas." After an 87 mile chase the General ran out of fuel and steam and eventually the Union volunteers were caught with some being hanged. (There is much, much more to the story than can be printed here.)

# **General News and Information**

### **Comrade George F. Coats**

A while ago Brother David Jackson was working on a file for the Pioneer Cemetery Association (Pioneer and Military Park 1313 W. Jefferson) and in it came across a picture of George F. Coats who was a member of the John W. Owen GAR Post No. 5 in Phoenix. Ever vigilant, he remembered seeing that picture in the book that I compiled years ago about the Post (which is available on the Department website) and emailed me wanting to know the source of the picture. I thought this is an easy one I obtained it from-well, where did I get it! I searched my files both on the computer and in my office—no luck. I know I didn't just grab it from thin air (I hoped) and the search was on. I finally found the source of it in a book titled The World's Columbian Exposition Illustrated March 1892-March 1893, published in 1893. Why was I reading that? Don't ask. But I figured as long as I spent this much time trying to find the source of that @#\$! picture, I may as well place it and the information contained in the book in the newsletter.

Comrade Coats died in 1901 and the following information is taken from the book and three newspaper articles.

# GEORGE F. COATS, NATIONAL COMMISSIONER FROM ARIZONA.

Hon. George F. Coats is a native of Iowa. At the outbreak of the war he was attending the Wesleyan University at Mount Pleasant, Iowa. On July 26, 1861, he enlisted as a private in Company E, First Iowa Cavalry, and remained in active service with his

regiment until mustered out September 9, 1864. After leaving the serving there one year, and then returning to Los Angeles. In May, 1879, he again located in Arizona, making his home at Phoenix, where, for six years, in connection with the leading fruit house of Los Angeles, he was engaged in the wholesale and retail fruit business. For the last few years he has been connected with no active business pursuits. Mr. Coats is recognized as an active member of the Republican party of his Territory, and in 1884 was appointed by Governor Tritle a member of the Board of Territorial Prison Commissioners. In April, 1889, at the request of Governor Wolfley, he accepted and was appointed a member of the Board of Capital Site Commissioners, which position he resigned to accept that of Commissioner on the World's Columbian Commission. The Legislature at its last session in February, 1891, made him a member of the Territorial World's Fair Commission. During his residence in Phoenix he has twice been elected Mayor of that beautiful capital city, first in 1884 and again in 1889, filling the office with credit to himself and his friends. He is prominent in Grand Army circles in the Territory, and takes an active interest in the order. In 1888 and again in 1889 he was appointed Ouartermaster General of his Department, and at the annual encampment at Tucson in 1890 he was unanimously elected Department Commander.[In 1887 he was the commander of the John W. Owen Post No 5 in Phoenix and was very active in the Post.] Mr. Coats is quiet and unassuming in his deportment, but a thorough and efficient worker in anything he undertakes. Should the Territory fail in its representation at the Exposition, it will be through no lack of effort upon the part of its Commissioner. Iowa State World's Fair Commissioners decided to utilize the stone dancing pavilion in Jackson Park, which stands on the Iowa site. The pavilion will be remodeled and added to at a cost of \$30,000 or more.

Daily Phoenix Herald Thursday February 2, 1888:

### **Bold Burglar Caught**

Last night sometime in the night the family of Mr. Geo. F. Coats were awakened by someone crawling over the fence between their residence and the rear of Ashler's store and heard what seemed the opening of the rear door of the store. Having awakened Mr. Coats, that gentlemen dressed and having satisfied himself that burglars were in the store, hastily procured Mr.

Lewis, the baker at the Phoenix Bakery nearby, and "Lame Billy" the night watchman at the engine house. Mr. Lewis and Billy raised an alarm at the front doors of the store while Mr. Coats watched for the game to appear at the rear door which it did in the person of two young men, one of which they caught but the other fellow though ordered to stop at the point of a pistol ran like a deer and though the pistol was snapped on him unfortunately it failed to go off and he escaped, though in doing so he passed Miss Laura Coats who was in the act of taking her own pistol to her father, but seeing the man escaping she drew the weapon on him and also attempted to fire but the weapon snapped. Both the pistol Mr. Coats had and the one in the hands of Miss Laura, had been loaded some four years hence the poor results in attempting to fire them. The fellow caught is a bum about town who signs himself John Berry. They did not succeed in getting away with anything though they would doubtless have made considerable of a haul had they not been discovered.

Mr. Coats marched his man over to the court house where he was locked up till this afternoon, and is at this writing, having his preliminary trial in Justice Wood's court.

Arizona Republic July 14, 1901,

When Sides Were Changed—The death of Hon George F. Coats recalls a curious alignment in the municipal election in 1889, when as the Republican candidate, he defeated John R. Loosely by the narrow margin of three votes for mayor. The town then was strongly democratic and the churches were not as active in local politics as they are now. Neither were they so powerful in membership. Loosely was an old-timer, a saloon keeper and very popular with all classes. Mr. Coats was popular though perhaps not so intimately known by the voters of Phoenix. Contrary to expecation the saloon influence was exerted almost solidly for Coats, and what was an even greater surprise, the church vote was almost solidly for Loosely.

Arizona Republic July 16, 1901,

Funeral of George F. Coats—the funeral of ex-mayor George F. Coats was held last evening at the undertaking parlors of Mohn & Easterling under the auspices of the John W. Owen post, GAR. Captain T J. Hill made a few remarks at the parlors and the ritualistic ceremony of the G. A. R. was performed at the grave. There was a large attendnce of friends, and the fire department, of which he was one of the organizers, turned out in a body with the apparatus

drapped in mourning. The flag on the city hall floated at half mast during the day.
