Awards

Sister Lee Nelson—Margaret Warner Wood Detached Tent No. 1—Dr. Mary Edwards Walker Award—" on behalf of the Sons of Union Veterans of the Civil War in grateful appreciation for *outstanding* service to the Order and for preserving the memory of Union soldiers and Sailors 1861-1865."

Just some of the examples of Sister Nelson's service to the Department of the Southwest and the SUVCW include:

May 2021—U.S. Grant Camp held its first ever Memorial Day Celebration at Citizens Cemetery, Prescott, AZ. As always, Sister Lee gave her very best at representing the DUVCW at our event. Sister Lee was in period dress and added immeasurably to the success of this dedication ceremony and so eloquently

represented her Tent—all done with great enthusiasm! Prior to the Memorial Day service, the Nelson's made 75 individual small metal flag holders for each Civil War Veteran's grave at Citizens Cemetery. They also made individual white flags that reflected the Veteran's unit of assignment—a truly incredible contribution to the Memorial Day event. They paid for all materials themselves. Sister Lee never asks for reimbursement for expenses incurred in supporting U.S. Grant Camp and SUVCW.

2021 Pearl Harbor Remembrance Ceremony—Phoenix—DSW and its Camps were well represented along with Sisters from Margaret Warner Wood Tent No 1, DUVCW and the Picacho Peak Camp No 1 Auxiliary. Sister Lee traveled 250 miles round trip to attend and participate in the ceremony. Following the ceremony, she joined with (and assisted) the Daughters and Sons for lunch with SUVCW Commander-In-Chief Michael A. Paquette.

August 2022—DSW Civil War Plaque dedication Ceremony for Citizens Cemetery, Prescott, AZ. Sister Nelson was of invaluable assistance—she and her husband Jack created, at their expense, the brochure for the event; she was instrumental in helping to coordinate the activity for over 100 attendees; decorated the VIP table; spoke on behalf of the DUVCW; and assisted with the plaque unveiling. An honored guest at the ceremony was Veteran Jerome Wilma, age 99. Lee was so kind and compassionate as she assisted Mr. Wilma thought out the ceremony.

May 2023—The day prior to Memorial Day 2023, Sister Lee helped organize and conduct General U.S. Grant's 3rd Annual Citizens Cemetery Clean UP event. She got the word out resulting in many of her friends participating in the clean-up. She was literally on her hands and knees cleaning Civil War graves and paying tribute to our "Boys In Blue." Her value to U.S. General Grant Camp is immeasurable. This is the third year that Lee and husband Jack helped with the pre-Memorial Day clean-up event.

Guests in attendance included Dominic Coffel, Tristen Hoffay and Ginny Smith.

Meeting Opening

Commander Hoffay opened the meeting at 11:30 am and Chaplin Heller provided the Invocation followed by all reciting the American's Creed and Pledge of Allegiance.

<u>Camp Officer Reports</u> <u>Commander Hoffay:</u>

Provided a summary of the Camp's participation in the recent Scottsdale parade. The parade was very well put together. The Camp participants enjoyed themselves and felt that our Camp was very well received by both the parade organizers and the attending public. The attention the Camp received can only serve to promote our mission and potentially attract new members. It is the Camp's intention to participate again in 2025.

Brother Mike Booth and Commander Hoffay Presented a certificate to a honorary Eagle Scout at the Elks Lodge in Phoenix.

Commander Hoffay discussed the JROTC program overseen by Brother, Dan Huskisson with a call for volunteers to assist with 21 presentations to be scheduled in the coming months.

Secretary / Treasurer Martorano:

Secretary Martorano provided the quorum report announcing that 11 brothers were present. A motion was made to waive the reading of the minutes from our last meeting as they were published in the department newsletter. The motion was seconded followed by a voice vote in favor of the motion.

Memorial Day—Brother Clark spoke about putting flags on the graves of Civil War Veterans in the GAR Plot in Evergreen Cemetery the Friday morning before Memorial Day. 24 May 2024 at 8AM we will meet to put in the Flags. The parade is on 27 May 2024 at 8:00 at Tucson Estates off Kenny Rd.

Eagle Scout presentation—Brother Clark is going to do an Eagle Scout presentation at Boy Scout Troop 247G the G standing for girls. Scout Comstock will be receiving a Certificate and a Patch from the SUVCW.

Minty moved to Tucson. He became Commander of the Negley GAR Post 1. In 1902 R. H. G. Minty started the General R. H. G. Minty Sons of Union Veterans Camp—precursor name to the SUVCW. Our Camp is named for him.

Good of the Order—Bill Blissett brought up, "This Republic of Suffering," book he got at the silent auction at the Department Encampment. He said it is very good and recommended it to the Camp. Closing—our next meeting is scheduled for 20 July 2024

The National Association of Civil War Nurses and the GAR

First of all, I want to thank Mark Clark, PCC of Minty Camp for this story—well sort of. He emailed me in March asking about the letters "F C & L" on the cross arms of a Civil War Army Nurse medal that he came across while doing some research regarding his 3rd Great Grandfather Sgt. Elisha Guthrie, Company B, 27th Indiana, who was wounded at the first of many battles at Winchester, A and hospitalized at the Union Hotel Hospital in Winchester. I wrote some nebulous answer about the GAR and a little later started doing some research about Civil War Army Nurses, so Brother Mark the real answer is contained in the following story!

The National Association of Civil War Nurses

I came across a neat little book titled, In Honor of the National Association of Civil War Army Nurses. Published by courtesy of the Citizens Executive Committee of Atlantic City, New Jersey, by Grand Army of the Republic, National Encampment 44th, Atlantic City, 1910, written by Kate M. Scott, National Secretary

The second page of the booklet contained two pictures; one of Col. Frank M. Sterrett, Executive Director, Past Department Commander, Missouri and Col. Robert B. Beath, Past Commander-in-Chief, both listed as "Honorary Members National Association Army Nurses."

Printed below is some very interesting information taken from the book:

The question has been asked, "Why are those old Army Nurses feted and cared for so tenderly at the National Encampment of the G.A.R? What good can they do for the Grand Army?

This question we will leave for the veterans themselves to answer. They will tell you that in the grey-haired, bent forms of those veteran nurses many of them recognize the gentle face upon which their eyes rested when they first opened after the work of the surgeon's knife was done; or the cool hands that soothed the fevered brow or held the cooling drink to parched lips. These are the women, who in their early womanhood, filled with the same patriotism that sent to the defense of the flag their husbands, fathers, brothers and lovers, went to the front to care for the sick and wounded.

It can scarcely be realized in this age, when the glorious Red Cross, with its perfect system of trained nurses, has made the vocation of a nurse an honorable one, when our Government is employing women as nurses, what nerve and patriotic devotion it took for the young women of the sixties to brave public opinion and enlist for hospital and field service.

At the beginning of the Civil War, Dorothy Dix, that grand "Angel of Mercy," offered her services to the Government and was appointed to enroll women for hospital nurses; as she could take none under thirty years of age, scores of young matrons and maidens who had seen their loved ones march to the front, offered their services independently, and were enrolled by surgeons, generals and colonels of regiments, serving without pay and rendering heroic service. The history of the nurses of the Civil War has been an almost unwritten one. When the war closed they went quietly to their homes, and took up again the daily routine of woman's work.

In 1881, Miss Dix invited all nurses whom she could reach to meet her in Washington and many responded. An organization was formed, called the Ex-Nurses Association of the District of Columbia, to meet each year in Washington. Miss Dix was elected president for life, but in 1887 her busy life ended, and Dr. Susan Edson succeeded her. Soon she resigned, and Miss Harriet P. Dame filled the office until she too folded her hands, her work being done.

At the [GAR] Encampment in 1892, there were quite a number of Nurses at Washington, and as not nearly all were members of the District Association, Mrs. Addie L. Ballou of San Francisco, Cal, called them together and organized the National

Association of Army Nurses of the Late War, with thirty-five members. Mrs. Ballou was elected president and Miss Hancock of Philadelphia secretary. The Association was to meet at each National Encampment.

Mrs. Ballou was too far away to attend the two following Encampments and the little society had no convention, but when the National Encampment was held in 1895, at Louisville, Kentucky, Mrs. Emily E. Woodley of Philadelphia, at the request of comrades of the G.A.R. called the nurses present together and re-organized the Association. By-laws and rules and regulations were adopted and Mrs. Woodley was elected National President

The object of the Association is to keep green the memories of those days of civil strife, to keep in touch with the Grand Army of the Republic in its efforts to perpetuate the grand principles for which the boys in blue fought and died, to seek out and aid unfortunate and needy nurses, and assist in procuring pensions.

Those admitted to membership must be women of good moral character, who served at least three months as a regular or volunteer nurse. Applications for membership must be endorsed by the applicant's nearest Post of the G.A.R.

At Cincinnati in 1901the title of the Association was changed to National Association of Army Nurses of the Civil War instead of the "Late War" to distinguish it from the National Association of Nurses of the Spanish-American War.

By Act of Congress in 1892 all nurses who were employed and paid by the Government are entitled to a pension of twelve dollars (\$12) per month, but no pension is allowed the volunteer nurses, who rendered equally good service and endured the dangers and discomforts of camp and field. A bill, however, is before Congress which it hoped will be passed and which will place the volunteer on equal basis with the regular nurses.

By Act of Congress, all nurses of the Civil War are entitled to burial in National Cemeteries, and several sleep the last sleep at beautiful Arlington.

The first organization of Nurses of the Civil War was the Veteran Nurses Association, which was formed in Philadelphia during the war. This was succeeded by the Andrew G. Curtain Nurse Corps of Philadelphia which was disbanded July 1910. . . .

At Toledo, Ohio in 1908, Lafayette Post G.A.R. of New York City presented an elegant silk flag to the Association, which will wave a salute to the veterans at Atlantic City as they march in review and as long as the G.A.R. and the Nurses of the

Civil War have enough veterans left to meet at Encampments.

I was fortunate enough to find the by-laws of the Association and the badge shown in this article is proudly displayed on page 2.

The Association disbanded in September 1931 when only five members were still living.
