

All Camps of the Department were represented, a fitting tribute to Jerry—who himself was a proud member of every Camp within the Department of the Southwest. His legacy of unity, service, and brotherhood will long be remembered by all who had the privilege to know him.

Hiram Tally: From Union Cavalryman to a Tragic Figure in Petaluma

In the autumn of 1915, the quiet town of Petaluma, California was shaken by a violent act committed by a man who had once worn the Union blue with distinction. Hiram ("Hi") Tally, a 75-year-old Civil War veteran, shot and killed Andrew J. McPhail, the respected owner of the McPhail Express. The case stunned residents who had known Tally for decades as a quiet, even harmless, old soldier living off a small pension.

A Life of Service: Born in Pennsylvania, Tally enlisted at the outset of the Civil War, joining Company E, 3rd Pennsylvania Cavalry. He rose to the rank of Corporal, serving in campaigns that helped shape the Union victory. Like many veterans, he carried physical and mental scars from the war. He later claimed his profound deafness was caused by the firing of artillery during his service. After the war he settled in California, working as a cook on local ranches and later operating a wagon and carriage painting shop in Petaluma.

A member of Antietam Post, Grand Army of the Republic, Tally embodied the image of the aging Union veteran living out his final years in quiet obscurity. He lived alone in a small room on Keokuk Street, existing largely on a government pension of one dollar a day.

The Shooting of Andrew J. McPhail: On the morning of October 20, 1915, Tally walked up and down Main Street in Petaluma, visibly agitated and carrying a pistol. Witnesses later recalled seeing him loitering in front of the McPhail Express office for hours. McPhail himself was well known in the community. Born in Petaluma in 1857, he had run the express business for years and was an active member of the Elks, Odd Fellows, Redmen, and the local Grange. Always described as cheerful and helpful, McPhail had just done a favor for a friend that morning, driving him across town before returning to his office.

At about 11:15 a.m., as McPhail sat on a box outside his express office, Tally approached. According to witnesses, McPhail stood to make way for a customer bringing in eggs when Tally muttered something. "What?" McPhail reportedly asked—his last word. Tally then raised his pistol and fired at point-blank range. The bullet struck McPhail in the mouth and exited behind his right ear. He staggered into the office and fell, dying instantly as blood pooled on the floor and sidewalk.

Tally smiled, walked calmly up the street, and began to put the pistol back into his pocket. D.W. Ravenscroft, a bystander across the street, ran after him and grabbed his arms from behind. Others—including Ed Sims, Henry Nauert, Herman Peters, D.J. Healey, and B. Studdert—helped wrestle the gun away as Tally struggled, grinning all the while, his face described as "livid" with a "dreadful look" in his eyes. He was loaded into the Peters & Peters auto and taken to the county jail.

On the way, Tally remarked chillingly: "I caught him lying, and I got him." To others he said, "I got him and I'm satisfied." Later, he told District Attorney Lea, "Tell Captain Dickson to get his muskets ready and shoot away. Let them place me along the wall and shoot away."

Evidence of a Disturbed Mind: Testimony at the inquest and later hearings revealed a man whose grip on reality had long been slipping. Tally said an "old veteran" had given him the pistol years earlier. Just the day before the shooting, he told authorities, he decided to kill someone and chose McPhail, waiting for him all morning. At other times he retracted his statements, saying he had no intention of killing the man.

When questioned by District Attorney Lea—who had to write his questions because of Tally's deafness—Tally contradicted himself frequently. He referred to long-dead acquaintances as if they were alive, spoke of "chicken thieves" and imagined slights, and confused the identities of people he knew. Witnesses described him as demented, a man whose mind was "undoubtedly deranged."

The Trial and Verdict: In April 1916, Tally stood trial before Judge Seawell. Throughout the proceedings, he behaved more like a spectator than a defendant, speaking only once to explain that the dagger found in his coat after the murder had been used "for sewing sacks." On April 15, 1916, the jury returned its verdict: Hiram Tally was insane. He was ordered committed to the Napa State Hospital for the Insane. Should he ever recover, he was to face trial for the murder of Andrew J. McPhail.

Final Years and Legacy: Hiram Tally never regained his sanity. His story ended not with a public execution or a long prison term, but in confinement. When he died, he was buried among his fellow veterans in the Grand Army of the Republic plot at Tulocay Cemetery in Napa, California—a resting place that honors the soldiers of the Union, even one who ended his life under a shadow of violence.

Today, looking back with modern medical understanding, it is likely that Hiram Tally suffered from dementia or Alzheimer's disease, conditions then poorly understood and without effective treatment. Rather than receiving compassionate care, he was placed in an insane asylum where he eventually died, his decline unrecognized as a medical illness rather than mere "insanity." His story reflects not only the struggles of Civil War veterans but also the limitations of early 20th-century society in caring for the aged and mentally ill.

The tragedy of Hiram Tally is more than a true-crime curiosity. It is a window into the unspoken burdens of Civil War veterans, men who carried their war scars into old age and often faced their twilight years misunderstood and forgotten.


