General News and Information

The Civil War in the Southwest and Captain Alexander McRae

Two of the three Camps composing the Department of the Southwest are named for generals who were conspicuous in their actions during the Civil War: General U. S. Grant (Flagstaff) and General R.H.G. Minty (Tucson). Our Phoenix Camp is named after the skirmish at Picacho Peak (or pass) which occurred in 1862. But, the actual fighting during the Civil War in the Southwest mainly occurred in the territory of New Mexico along the Rio Grande River from Mesilla in the south to Santa Fe (and Glorieta Pass) in the north. Did you know that Mesilla was the capitol of the short-lived Confederate Territory of Arizona? (That's for another time.)

Anyway, in October 1861 Confederate General Henry Sibley and 3,200 Texas troops left San Antonio heading toward El Paso. Once at El Paso the immediate plan was to invade and occupy New Mexico (held by Union forces) by living off the land and following the Rio Grande River north to capture Fort Union in northern New Mexico (with its many supplies). Once that was accomplished it was on to seize the rich mines in the Colorado Territory, head west to Salt Lake City and then take over the ports in San Diego and Los Angeles.

In January 1862 he marched 2,500 of his troops to Mesilla, New Mexico and in February started up the Rio Grande toward Fort Craig (a Union fort some 70 miles north) which he hoped to take over and replenish his army with the supplies held there. Finding the fort unassailable (manned by some 3,800 soldiers—Union troops and New Mexico Volunteer regiments) he decided to draw the troops out by moving around the fort to the north and occupy the Rio Grande ford at Valverde—hoping to draw General Canby out to defend his supply lines—which he did.

On February 21st the battle started. The Union troops had the advantage with artillery, mainly the six guns under the command of Captain Alexander

McRae, but in the afternoon his battery became exposed and with little to no infantry support the Confederates charged killing McRae and seizing the battery. The tide thus turned, Canby retreated back to the fort.

Let's see what Wikipedia has to say about this.

"At the beginning of the American Civil War, McRae's father wrote urging him to change sides. Nevertheless Captain McRae retained his commission as a U.S. Army officer and served in the Union Army, while his four brothers fought for the Confederacy. In operations of Colonel Edward Canby in the New Mexico Territory, he was given command of an artillery battery of six guns. On February 21, 1862 he was engaged in the Battle of Valverde, where he was wounded twice then killed defending his guns as they were overrun by Confederate Army troops of the 5th Texas Mounted Rifles Regiment. He died at the age of 32, and was buried at Fort Craig

"In his official report of the Combat of Valverde, Colonel Canby, wrote:

"Among the killed is one, isolated by peculiar circumstances, whose memory deserves notice from a higher authority than mine. Pure in character, upright in conduct, devoted to his profession, and of a loyalty that was deaf to the seductions of family and friends, Captain McRae died, as he had lived, an example of the best and highest qualities that man can possess."

"In 1867 his body was exhumed from its grave in New Mexico Territory and carried across the country from Army post to Army post with a hero's escort to be interred at the United States Military Academy Post Cemetery at West Point."

The Union losses were 68 killed and 160 wounded. Confederate losses were 36 killed and 150 wounded.

General Sibley's troops then went on to occupy Albuquerque and Santa Fe but met their Waterloo at the Battle of Glorieta Pass (some 20 miles southeast of Santa Fe) a month later, forcing their retreat back to Texas and ending the Confederate version of "Manifest Destiny."
