Pearl Harbor Remembrance Day

Brother Avery Frantz organized a Pearl Harbor Remembrance Day ceremony at the USS Arizona Memorial Gardens on the Salt River Reservation. The ceremony started at 10:55 coinciding with the attack of Pearl Harbor and the flyover of a WWII plane.

The history of the Allied Orders and the attack of Pearl Harbor were shared as well as the symbolism of the Memorial Gardens. The USS Arizona Memorial Gardens is 608 ft long which matches the ship size and poles outline the shape of the USS Arizona. There are 1,500 poles which represent each death and the gaps between the poles represent a crew member that survived.

Wreaths were then dedicated at 11:10 which marked the sinking time of the USS Arizona. Brother Jerry Bloom, PDC, and Brother Avery Frantz placed the US Camp Grant No. 3 SUVCW wreath in honor of the Pearl Harbor victims. A tour of the relic center was undertaken where members looked at pieces of the USS Arizona.

Other organizations present were DUVCW, WRC, ASUVCW and the UDC.

Veteran of Pearl Harbor attack laid to rest

Carl Johnson, 18, a veteran of Pearl Harbor was finally laid to rest with his parents in Greenwood Cemetery on Jan 15, 2021, after missing for 8 decades. Carl Johnson, a local valley boy, joined the Navy when he was 16 and when he was 18 obtained the rank of 1st Class Seaman. During the attack on Pearl Harbor he was stationed on the USS West Virginia. The ship was struck and Carl Johnson ran to stabilize the ship, but it was too late and he went down with the ship.

In 2020 a mandible and teeth were found in the harbor and thanks to DNA testing they were able to identify the remains and return him back to his family. He was flown to Phoenix from Hawaii and a fitting military service was done.

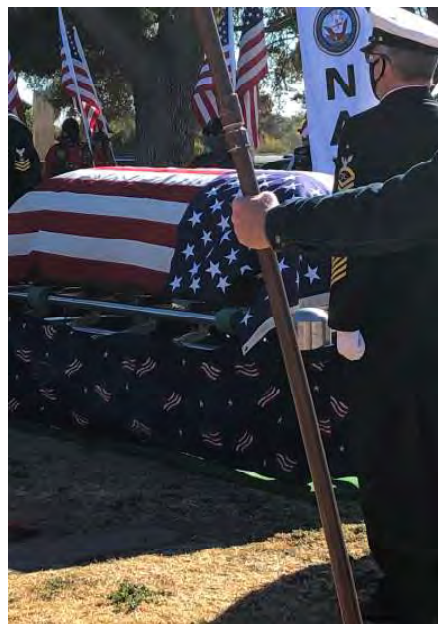

January 16, 2021, Camp Meeting Minutes

Call to order:

A meeting of General U. S. Grant Camp No. 3, Sons of Union Veterans of the Civil War was held virtually via Zoom on January 16, 2021. The meeting was graciously hosted by Brother John Conrad, PDC.

Forty-seventh National Encampment, Chattanooga, Tenn, September 18-19, 1913, Membership: 180,227

This Encampment was held at Chattanooga, Tennessee and was the first one held in the South. Here is some interesting information taken from the 1913 GAR Journal. I am publishing information about it not only because it was the first to be held in the South but because of the gift that Commander-in-Chief Alfred B. Beers received

“A semi-official meeting of the Forty-Seventh National Encampment of the Grand Army of the Republic was held at the City Auditorium, Chattanooga, Tennessee, on Tuesday evening, September 16th, 1913. (There were several days of activities prior to the actual Encampment hence the term “semi-official.”)

“Hon. Newell Sanders, President of the Chattanooga Encampment Association, welcomed the Grand Army of the Republic and its Auxiliary and allied societies and its friends to Chattanooga. We are here as Southerners, as well as Northerners to show that between the States of the Union everlasting peace reigns. Commander-in-Chief Beers, on behalf of the Encampment Committee, I now present this gavel made of wood which grew on Lookout Mountain and turn the meeting over to you.

"The Commander-in-Chief was enthusiastically applauded when he received the historic gavel and assumed charge of the meeting. . . . He said that that this Encampment, being the first held on a battlefield of the South, would prove a powerful factor in strengthening the bonds of fraternity and unity between the North and the South.

The Bryant Post Quartette then sang, “We are Tenting Tonight on the Old Camp Ground.”

Comrade T. H. Hagerty of St. Louis, Past Chaplain-in-Chief, then presented to the Commander-in-Chief a gavel made of wood from historic places. He said in part: “The wood used in the head of this gavel is from a tree on Lookout Mountain, with a bullet imbedded in it, which I am told was fired from the Confederate ranks towards an advancing Union officer. The handle

is of hickory, from Wilson Creek battleground, southwestern Missouri. Holding the handle of the gavel out from you the upper part of the star inlaid in the head of the gavel is made of wood from the Spanish flagship Regina: the wood in the point next to the right is from the battle ship Maine; the next is from the Confederate gunboat, which sank in the river below Memphis; the next is from Andersonville, and the next is from the Confederate army headquarters at Richmond. The corner quadrant is from the home of Lincoln at Springfield, and the next quadrant is made of wood from the home of General Sherman in St. Louis; the next is from the house in which General Grant read the surrender of General Lee, and the last is from Grant's log cabin. The center piece of wood is from the frame of the Liberty bell at Philadelphia. All of this symbolic material was gathered by me during the last three or four years in my travels over the country.”

The Commander-in Chief accepted the gavel with words of appreciation for the gift, and requested the Bryant Post Quartette to sing a song especially written by one of its members for this occasion . . .”

Wouldn't you like to have that gift! Thanks to Sister Verna Maleski who made me aware of this Encampment.

I've Got a Secret

Mr. Samuel J. Seymour, the last living eyewitness to the assassination of President Abraham Lincoln at Ford's Theater in Washington, D.C., was the mystery guest on the February 8, 1956, episode. Mr. Seymour (March 28, 1860 – April 12, 1956) was actually 95 years of age at the time of this appearance instead of 96.
