#### 80th Pearl Harbor Remembrance Day

On December 7, 2021, the 80th Pearl Harbor Remembrance Day observance was held at the Wesley Bolin Plaza across the street from the Arizona State Capitol building in Phoenix. December 7th is always set aside in Arizona to remember the day and honor the lives that were lost during the sneak Japanese air attack on US Naval Station Pearl Harbor and Hickman Air Field on December 7, 1941—a day which truly lives in infamy. The USS Arizona (BB 39) suffered direct bomb strikes causing the battleship to explode and sink. The death toll on Arizona was 1,177. Total casualties to the United States were 2,343 killed, 960 missing and 1,272 wounded.

Some 75 organizations participated in this annual wreath-laying event including four of the Allied Orders of the Grand Army of the Republic. Those representing the National Orders were:

The Department of the Southwest and its Camps were also well represented along with Sisters from the Margaret Warner Wood Detached Tent No 1, DUVCW and the Picacho Peak Camp No 1 Auxiliary.

After the ceremony an outstanding and well attended luncheon was held at the Old Spaghetti Factory, 1418 N. Central, for the participants from the various Orders.

**Special recognition** goes to Sister Verna Maleski, National Junior Vice President, Daughters of Union Veterans of the Civil War, for her wreath making ability and for coordinating the event with the Allied Orders. Sister Verna has done this for many years and it has not gone unnoticed or unappreciated. Thank you Verna!

## General U.S. Grant Camp Commander Bill Smith's link to Pearl Harbor

I had two uncles serving in the U.S. Navy at Pearl Harbor on December 7, 1941: Joseph and Michael Giovenazzo.

The oldest, Joseph, had served on the USS Arizona but was promoted to Water Tender 1<sup>st</sup> Class and was now serving on the USS Vestal, a repair ship tied outboard of the Arizona. He had been in the Navy for

six years with an enlistment due to end on 16 Dec 1941. Michael was a Water Tender 2<sup>nd</sup> Class serving on the Arizona with an enlistment ending on 3 Jan 1942.

Joseph was living in married housing on base when Michael and a home town U. S. Marine friend visited with him on 6 Dec 1941. They could have spent the night with Joseph but decided to return to their ship/base that evening.

The Japanese attack on December 7th proved to be fatal to Michael and he is entombed in his ship—the USS Arizona (BB 39) at Pearl Harbor. Joseph survived the attack.

On 22 Dec 1941 the family received word that Michael was being reported as "Missing." On Christmas Eve, they received a telegram from the Navy Dept. "he had been found alive." On 16 February 1942 the family received a letter from the Navy Dept, stating that Michael was 'officially listed as a Casualty". The letter also stated that "the Giovenazzo reported safe on Christmas Eve was a brother, Joseph." Joseph became a career Navy man, changed his last name to Givens and retired as a Chief Petty Officer.

My family of 10 will be at the USS Arizona Memorial at Pearl Harbor on 7 Dec 2021. Also my San Diego cousin J.R. Givens (only son of Joseph Giovenazzo) will be there at the same time with 14 members of his family. Since 1986 (45th Anniversary), my wife and I have been attending the 7 Dec ceremony every five years and with 24 of us this will be the biggest family representation yet.

#### **Missing In America Project**

Brother Avery Frantz, Dept CW Memorial Officer, Verna Maleski, DUVCW National Junior Vice President, and Sister Maura Mackowski, Past Tent President of the Margaret Warner Wood Tent No. 1 SUVCW attended the Memorial Ceremony for Jerome Cranke, a Spanish American War Veteran, along with the Colonial Dames of the 17th Century. Jerome Cranke, a member of the US Hospital Corp, enlisted in 1899 and was a chiropractor in Phoenix. Passing away in 1929, Jerome and his wife were cremated at the Greenwood Cemetery in Phoenix but their ashes were never claimed. Thus he sat on the mortuaries shelf for 92 years until genealogists of the Missing In America Project were able to discover he was a veteran of the Spanish American War. His ashes, his wife's, and

Vietnam veterans were interred at this Dec 29th ceremony. After the ceremony a luncheon was held at Red Devil Pizza in Phoenix

#### Union Civil War monument—update

Following a Dept Officers Meeting it was decided that the best place for monuments would be in cemeteries, to be most contextually correct. Citizens Cemetery in Prescott and Evergreen Cemetery in Tucson were contacted and both approved the idea. There are more than 50 Union Civil War soldiers buried in the Prescott cemetery and the Tucson cemetery has a GAR burial section.

The Yavapai County Board of Supervisors approved the placement of a plaque at the Citizens Cemetery in Prescott to be provided by the DSW at no cost to the county (Yavapai County Facilities Department at the Citizens Cemetery will install it). Plans are to have a plaque installed in the spring of this year.

Wording on the plaque:

"CITIZENS CEMETERY, PRESCOTT, ARIZONA CIVIL WAR VETERANS

Citizens Cemetery is the final resting place of more than fifty men who fought for the Union as Soldiers, Sailors and Marines during the American Civil War, 1861-65. In the years following the war, these Veterans relocated to Prescott (Yavapai County) to become early settlers and pioneers of the "Arizona Territory". Their bravery and self sacrifice were instrumental in preserving our United States of America. Their migration to the "Arizona Territory" ultimately lead Arizona to Statehood in 1912. These brave and courageous men were 'Victorious in Life - Immortal in Death."



## GAR Comrades were honorary members of the Veterans of Foreign Wars (VFW)

During the GAR's 55th Annual Encampment in 1922, George S. Geis of the VFW addressed the Encampment. I copied the whole exchange from the Encampment Journal between him and Comrades of the GAR which was interesting, at times humorous:

THE COMMANDER IN CHIEF. The representatives of the Veterans of Foreign Wars are here. May they be admitted, one man and only one to speak for them, and he not very long? May I admit them? [Cries of "Yes."] Let them come in.

THE OFFICER OF THE DAY. Commander in Chief, I have the honor to present to you Comrade George S. Geis, past senior vice commander in chief Veterans of Foreign Wars and Sons of Veterans

THE COMMANDER IN CHIEF. Commander, I am glad to meet you, and I am glad to show you the finest looking body of men you have ever had the opportunity to look upon.

Mr. George S. Geis, of Chicago Ill. Commander in Chief, I agree with you that it is not only the finest looking body of men, but it is the finest bunch of men that we have in our whole country. It has been my privilege to meet them many times, but to-day I have the distinguished honor of meeting them, for I bring to you from the national encampment at Detroit, Mich., which met last week, of the organization which represents foreign service, the organization that represents three or four million of boys like you were 50 years ago, of boys who will be like you are 50 years from now, 100 per cent Americans and trying to follow the principles which your organization in years past set up for us; I come to bring the greetings from the boys who served in the Philippines, in China, in France, in Germany, in Siberia, and who carried the flag on foreign soil. Every one of them has served in the Army in time of war on foreign soil. It is the organization of Veterans of Foreign Wars of the United States. During the past year we have organized 26 departments. During the past year we have put in 600 new posts in many States and cities in the country. During the past year the national council of administration admitted the Grand Army of the Republic as honorary members, so you boys, all of you, are honorary members of the Veterans of Foreign Wars of the United States. [Applause.] I shall not take your time. You have lots of work to do. I want to say that my father is a comrade of yours, a member of Lyon Post No. 11, of the Department of Nebraska, for many years. It has been my privilege to meet you in many national encampments. One year I

was senior vice commander in chief of the Sons of Veterans.

If I should ask you how many of you had relatives in the late war among our 4,000,000 young men, I will bet that over 90 per cent of you had relatives in that war. We are carrying on the work that you have begun. We wish you Godspeed, good luck, and good-by, and hope to meet all of you in Detroit. I thank you.

THE COMMANDER IN CHIEF. Comrade—I think I may say "comrade" to you, although you are a little bit young to carry that designation [earlier in the encampment the commander in chief announced that the average age of members in the GAR was 80]—I will ask on behalf of the Grand Army of the Republic, Col. Clarendon E. Adams, who served in many wars, and with distinction and honor wherever he served, and who as a private citizen, has earned the respect and honor of his neighbors, to respond to your welcome.

Past Commander in Chief Clarendon E. Adams. Commander in chief, commander of Veterans of Foreign Wars, I was very much impressed, commander in chief, with your introduction in representing to this young commander, this mighty host of men who answered the call of Lincoln and performed one of the mightiest historical events that have come to any people. Your ancestors were the men that did that great and valiant duty. You are the lineal descendants of those men. I was glad indeed, as was just stated—. I have just gone down the line of the record of the men that this young comrade represents. I find that 67 per cent of them were the lineal descendants of the Grand Army of the Republic. That is the record in Washington and they are among the noblest of our Nation to-day. Mr. Commander, will you take back with you the compliments and the greetings from the Grand army of the Republic and say to them that there is always a welcome for them at our meetings? You might say, sir, that the great implements that they used in their service which were so destructive were also used in our Army. We had flying machines, we had submarines, and we had smoke screens. Now, that flying machine proposition, every one of you was equipped with a Liberty motor. I was there and I know what I'm talking about. I flew. [laughter.] The command flew; the division flew; and we would be flying yet sir, if the Johnnies hadn't quit shooting at us. You had your smoke screen but you didn't know how to use it. You put it down in front of you and obscured your position. We put ours down, it was a dust screen, and we put our dust screen down in the rear of us, and we kept up a might good screen too! [Laughter.] I thank you.

# Department Orders Department of the Southwest Sons of Union Veterans of the Civil War



#### DEPARTMENTAL ORDER 04 (SERIES 2021-2022)

#### Department Encampment, Applicants

By the authority vested in me as Commander of the Department of the Southwest of the Sons of Union Veterans of the Civil War, the National Charter, Constitution and Regulations, the National Policies, and the Department Bylaws, the following is ordered:

- Brothers are reminded to attach a black mourning ribbon to their membership badges through January 30 in memory of Real Son and Life Member John Wilson Oliver Jr., who died on November 15, 2021.
- 2. The 2022 Department Encampment will take place on Saturday, March 26 from 11 AM to 2 PM at Phoenix City Grille, 5816 N 16<sup>th</sup> St, Phoenix (just south of Bethany Home Road & 16<sup>th</sup> Street on the west side of the street). Commander-in-Chief Michael A. Paquette will be in attendance. Seating is limited to 40 people; elected and automatic delegates and the CinC will have first preference, but Sisters of the Allied Orders, non-delegate Brothers, and spouses/guests are encouraged to attend. Please let me and S/T Dale Enlow know if you plan to attend so we have an accurate headcount. Lunch will be served. There is no cost for lunch, but there will be a cash bar.
- 3. In order to standardize actions throughout the Department and to comply with the regulations of the Order, the following procedure regarding applicants for membership shall be followed by each Camp, effective immediately:
  - A potential member is normally brought to our attention in one of the following ways:
    - Personal recommendation by an existing Brother in Good Standing, OR
    - o Digital contact via National, Department, or Camp internet presence, OR
    - o In person declaration of interest at public ceremonies, memorial, parades, etc.
  - The primary point of contact shall be either the recommending Brother or the Junior Vice Commander
    who shall evaluate the potential member as to moral character by communication and interaction with
    the interested party.
  - A Committee of Three shall consist of the Camp Senior Vice Commander, the Junior Vice Commander, and the Camp Secretary/Treasurer or any of their respective designees. This committee can utilize any resource they desire to assist in the determination of eligibility, such as the Department Junior Vice Commander, the Department Graves Registration Officer, the Camp or Department Historian(s), the recommending Brother, or a trusted genealogist. The committee shall review the SUVCW Dishonorable Discharge List to ascertain whether the potential member is on that list.
  - The senior ranking officer shall serve as the chair of the committee, and all deliberations and decisions
    may be made in person, by telephone, or by any electronic means (including teleconferencing or email
    exchange).
  - If the Committee of Three finds that the potential member is eligible for membership, the Camp Secretary or Secretary/Treasurer shall process a Form 30 and the signed / witnessed copy of the Form 3 membership application (along with proof of service for full membership) and forward such to the Department Sec. Treas. for his final review. The Forms 30 and 3 should be forwarded to the Department prior to the potential member's initiation ceremony unless this would cause an unreasonable delay. In the event that the committee does NOT recommend membership, the Junior Vice Commander shall communicate the concerns with the potential member and allow that person to respond and / or submit additional documentation.
  - Prior to the Camp Initiation Ceremony, the Camp Commander shall announce the name of the potential member and ask the Camp Brothers if anyone has an objection to the potential member's admittance as a Camp Brother.

- If there are no objections, the initiation shall proceed. However: If an objection is raised, the objection
  is then detailed, discussed, and ruled upon before proceeding to initiate the potential member.
- 4. The Camp Council has established a General Monuments Fund, into which all unrestricted monuments or memorials donations will be placed. If a person wishes to restrict a donation to a particular charitable purpose, that should be discussed with the Secretary/Treasurer
- 5. Any Brothers interest in joining the Sons of Veterans Reserve should contact Brother Bob McCord.
- We still need a Newsletter assistant editor to assist David Swanson. Anyone with an interest in newsletters is welcome, no experience necessary! Reach out to Brother David if you can help.
- 7. I encourage all Brothers to actively support their Department and Camps by attendance at Camp meetings, volunteering for programs, and serving in the various officer position opportunities.
- 8. I encourage all Brothers to continue to observe CDC health and safety guidelines at Camp meetings and events.
