## 133rd National DUVCW Phoenix conventionthe Daughters need your help!

As most of you are aware of, the Arizona Daughters is hosting the 133rd National DUVCW convention at the Embassy Suites in Scottsdale. It is the 1<sup>st</sup> time a national convention has been hosted by a detached tent. Only Departments with 3 or more tents have been allowed to host until now. There are still some naysayers that anticipate we will do poorly because of our lack the experience. We have no doubt that we will show them differently. We have some "firsts" planned that have never been done at a National Convention before. Highlighting the fraternity between the Sons and Daughters of Arizona is one of them. We consider this a milestone for both of our organizations. But we need your help in putting together an unforgettable experience for our out- of- town guests.

Please visit the DUVCW website for general information, meal choices and reservations. (duvcw.org) From the main page, access 'About Us.' On the next page you will see 'National Convention.' That page will give you everything you need. The "at a glance" page will give you the activities for all 4 days. You can choose your meals, tours and reserve a room if you wish to stay overnight. If you can only stay one night, I would suggest Saturday night. We have an excellent room rate of \$124 plus tax.

#### Wednesday July 31<sup>st</sup>

This is Opening night – This is the most important night of the convention! We need the SUVCW officers/members to be escorts for the National Officers and Posting of the Colors. Preferably in uniform or a portion thereof. There will be 30-35 officers that will need to be escorted to her seat or station. There will not be enough of you to go around so you will escort more than one officer.

On opening night, the Dept Commander should bring greetings on behalf of the Dept of the SW. The Mayor of Scottsdale will be in attendance & bring greetings. This is our "dressy" night – the rest of the banquets are casual dress.

**The Presidents Reception** follows the opening night ceremony. It will be hosted by the Arizona Brothers and Sisters (the 1<sup>st</sup> time this has been done at a DUVCW convention). We will have finger type foods, cake, tea and coffee. The cake will say welcome from the Sons and Daughters of Arizona. There is no charge for the reception.

We are in business sessions all day Thursday and Saturday—Friday is half a day. We close the convention on Sunday afternoon. It is traditional that everyone goes out for Chinese on Sunday night but we have opted for Mexican instead. You are welcome to attend any of our business sessions.

#### Thursday – August 1st

9AM opening of the Convention – Posting of the colors again.

Camp Commanders should bring greetings on Thursday morning.

**Transportation on Thursday!** We need 2-3 Sons to be "hosts" and provide transportation 1-4PM for husbands to and from the Arizona Heritage Center at Papago Park. I anticipate 6-8 for the tour.

**Thursday night banquet** - our speaker is David Swanson who is giving the program on the GAR. We would like as many of the Brothers to attend the banquet as possible! There is an auction following the banquet. Casual dress.

#### Friday – August 2nd

We need 2-3 Sons to provide transportation from 1-3PM for guests to and the Western Spirit Museum. We will utilize the hotel shuttle but it only holds 7. We are anticipating 40-50 for this tour. The Daughters will provide transportation too.

#### Saturday - August 3rd

**Saturday night banquet** – our speaker is John Conrad who is giving the program on the Civil War in Arizona. Casual dress. Departments and individual tents put on skits after the banquet – followed by another auction. This is our most "fun" night.

#### Sunday – August 4th

**Sunday morning** worship and memorial service followed by the Granddaughters breakfast.

If you must pick one night to stay at the hotel, Saturday would be it. It will be a fun night. Then you can join us in the morning for the worship and memorial service followed by the granddaughter breakfast. Even though the hotel has free breakfast we are having a breakfast to honor the granddaughters. We'll also need your help in carrying and unpacking boxes for the hospitality suite and meeting room. Several of us will be there Monday afternoon to begin setting up. #### **November 18, 2023, Camp Meeting Minutes** Location:

Scottsdale City Library—Mustang room 10101 No. 90th Street. Scottsdale, Arizona

**Opening**—the meeting started at 1:30PM on November 18, 2023 with 16 Brothers in attendance, 6 Sisters and 2 guests, with Brothers Doug Krause a total of 23. A quorum was in attendance (6+) Members.

*Call to* order—Commander Hoffay welcomed Brothers, Sisters and guests to the meeting. CC Hoffay led the rituals of Principles, Chaplain Jim Heller the Divine Blessing, CC Hoffay the American's Creed and the Pledge of Allegiance. The meeting was called to order by Commander Hoffay.

*S/T report*—Interim S/T Hooker made a motion to bypass reading the minutes since they were published

in the department newsletter. The motion passed. PPC1 bank account balance [was given] most of the quarterly expenses being office supplies, new member kits, and booking the Mustang room for future meetings. S/T Hooker mentioned some of the camp members have issued checks and sent in Zelle payments (preferred method of payment) for 2024 dues and that they will be processed soon and then encouraged all to send in dues as soon as possible. Currently 63 members in PPC1.

S/T Hooker suggested that members take a blank business card and try to recruit at least 1 new member in 2024. New applications are currently in process for supplemental ancestors but will be completed after today's S/T office is filled on a permanent basis.

Officer Report—Department Commander Hooker gave an update that our Department of the Southwest annual Encampment has been booked. It will be held on March 2nd, 2024, at the Hassayampa Inn in Prescott, Arizona starting at 9am. He encouraged all present to attend. There is a planning committee working to detail the event, but DC Hooker encouraged input from any and Department members that wish to participate. There will be a National Officer attending, this has been confirmed. DC Hooker shared that the DSW will be making a charitable contribution of \$350 to the Missing In America Project and presenting it at the Department Encampment to the 2nd Project's Vice President. The SUVCW has been involved in past activities with MIAP and several members shared past experiences we have held with them.

**DSW Signals Report**—Officer Jeff Burgess gave a report on his activities related to the Dept website. A new email address was purchased along with a process implemented to boost security, improve aesthetics of the site, create a more professional look, and help with spam. A few members shared their negative experiences with spam/spoofing and potential scams. Brother Burgess will be posting and sending out a survey to help with any suggested changes to the website, which may also help with membership recruiting.

*Old Business*—SUVCW bench placed in memory of the John W. Owen Post No. 5 GAR at the Pioneer & Military Park, Phoenix. Brother David Jackson reported that the bench is in the process of being installed, with the concrete base being poured very soon. The hope is that it can be installed early in 2024, and that the SUVCW will hold a ceremony to dedicate the memorial bench. [See article further in the newsletter].

*New Business*—DUVCW National Meeting. PDC John Conrad mentioned the DUVCW National Meeting which will be held in Scottsdale in 2024 and encouraged all Brothers and Sisters to attend. The meetings will be held from July 30-August 4th, 2024. <u>Opening night escorts from the SUVCW are needed</u>, Brothers should please consider volunteering for this activity as 10-12 will be needed. Suit and tie or Civil War re-enactor uniforms are acceptable attire for escorts.

*Chaplain's report*—CC Hoffay asked Chaplain Heller to give a brief memorial to our passed Brother Charles Fox. Charles was not able to attend any meetings but expressed an interest in joining the SUVCW and leaving an appreciation of his family history as a legacy. RIP Brother Fox.

**Pearl Harbor commemoration**—DC Hooker explained the reluctance to join the Pearl Harbor proceedings this year. The Margaret Wood Tent of the DUVCW has already decided not to join as well. The camp agreed the event would not be something we officially want to support.

Gift items by the DUVCW—Margaret Warner Wood Tent Sisters Lee Nelson and Gretchen D'Andrea conducted a drawing to give away some seasonal gift items. Three Brothers went home with some holiday cheer! Union Civil War soldier in Tempe Double Butte Cemetery—CC Hoffay discussed potential grave dedication ceremony for a recently discovered Union Civil War soldier in Tempe Double Butte Cemetery; more to come. Brother Avery Franz, our DSW Graves Registration Officer was the one who made the discovery. DC Hooker mentioned that Brother Avery is looking to move out of that role, but if any members have an interest, please reach out to DC Hooker.

*Massing of Colors*—CC Hoffay and PDC Heller discussed the Massing of the Colors event coming up in Sun City. PPC1 is planning to march in the event; we will be displaying Department and Camp flags at the march. Attendance is open to all. [See article in newsletter.]

**Oak Leaf Clusters**—CC Hoffay asked about the design of Oak Leaf Clusters indicating a Union Civil War ancestor and explored a possibility of displaying them in a better way. The 1907 Civil War Campaign Medal gives us a model for putting pins on separate ribbons vs. pinning onto the jacket.

*JVC Report*—Bother Mike Booth gave a presentation about his efforts to boost recruiting for the Camp. As PPC1 Junior Vice Commander, he will be instrumental in that capacity (and he looks great doing it in his bright blue CW Period Union uniform). He has some community outreach events already scheduled around the East Valley in that regard. We wish him luck in his new role. Excellent presentation with lots of photos of his ancestors, and props including medals, currency, and even an old drum and bugle, sure to get the attention of potential members!

# Department of New Mexico Grand Army of the Republic

#### By David Swanson

As the Department's GAR Records Officer, I recently completed a book regarding the history of the Department of New Mexico Grand Army of the Republic (available for download on the Department website, suvcw-southwest.org) which covers many of its activities from 1868 until 1929. I am pleased that the book is also now in the reference room collection of the New Mexico State Records Center and Archives at Santa Fe. Quite a few years ago I did the same for the Department of Arizona GAR and that book, and others, are in the reference library of the Arizona State Library, Archives and Public Records in Phoenix.

Since we are the SUVCW Department of the Southwest, which comprises the two states, these books give us an idea of what our GAR "ancestors" accomplished during the territorial days and statehood days of both. I use the term "ancestors" since as most of us know, the SUVCW is the congressionally chartered successor organization of the GAR.

One of the long-time Comrades of the New Mexico Department was Smith H. Simpson who lived in Taos—about 70 miles northeast of Santa Fe. He died in 1916 and was an integral part of the Department having just been elected as its Medical Director in 1915. Below is information about Simpson, as contained in my history, that I thought would be of interest:

The following information is obtained from The Library of Congress: "Captain Simpson died April 3, 1916, being just a month less of eighty years of age. His funeral was held three days later and conducted by Bent Lodge No. 1 A. F. & A. M. of Taos and Carleton Post No. 3. G. A. R. of Santa Fe and by common consent all the stores closed and the whole town turned out for the funeral. He is buried in Kit Carson Cemetery near his old friend and comrade of Indian fighting days."

The San Miguel County, New Mexico, Genealogy & History website has this in part to say about Simpson:

... After leaving the military service he went to Las Vegas [New Mexico] and in the latter part of the same year he removed to Taos, which was his home for the remainder of his lifetime. From 1859 to 1861 Captain Simpson served as the confidential clerk of Kit Carson, who was, during that time, Indian agent at Taos. On November 28, 1863, he enlisted as captain of Company I, First New Mexico Volunteers, and served until September 26, 1866, when he was mustered out at Albuquerque and returned to Taos. . . . In the spring of 1861, after the firing on Fort Sumter, Captain Simpson, Colonel Ceran St. Vrain, A. H. Pfeiffer, Jim Enos, Dave Wilkens, Tom Barnum, Solomon Beuthner, McPherson, Johnnie Whitesides, Van Hecklen, Fred Muller, and several other Americans raised the American flag in Taos plaza and nailed it to the flagstaff so that the Confederate sympathizers could not haul it down in the night time. And Captain Simpson saw to it that "Old Glory" has been kept flying in Taos, by day and by night, ever since. In the Civil War Captain Simpson saw much hard service, taking part in the fights at Arivipa Cañon, Penal, Salt River, Sauz, Ochava, Waterhole Cocotopi, Naposite, and San Carlos, in which last action he was again wounded.

For nearly two years he was in command at Fort Goodwin, near the present town of Globe, Arizona.

In 1867, Captain Simpson married Miss Josefa Valdez, daughter of Juan Valdez, of Taos, who died about six years ago. Captain Simpson was the intimate friend and confidant of Kit Carson, and they were together in numerous fights with the hostile Indians. Almost the last wish expressed by Carson before his death was, "Tell Simpson and Tom Boggs that I want to be buried at Taos"-and the wish was carried out. It was largely through the efforts of Captain Simpson that a monument was erected over the grave of Kit Carson by Carleton Post No. 3, G. A. R., and an iron fence built around the grave plat by the Grand Lodge, A. F. and A. M., of New Mexico. He was an ardent and faithful member of the G. A. R. of New Mexico, and served as its senior vice-commander and also for many years as its medical director. . . .

Fearlessly as he had faced the many dangers encountered in his fourteen years of military service, so fearlessly he faced the approach of death. He had lived his life, he had finished his work, he was ready to go, and calmly he awaited the end. Interment was made in the American cemetery in Taos on April 6th. The G. A. R. burial service was read at the grave by Comrade Jacob Weltmer of Santa Fe. [Source: Old Santa Fe (July 1916) Vol. 3; No. 11; transcribed by Richard Ramos]
