#### **November 16, 2024, Camp Meeting Minutes** Location:

*Call to order*: Commander Hoffay welcomed Brothers, Sisters and guests to the meeting. CC Hoffay led the rituals of Principles, Standing Chaplain Jeff Burgess gave the Divine Blessing, CC Hoffay the American's Creed and the Pledge of Allegiance. The meeting was called to order by Commander Hoffay. *S/T report:* ST Martorano provided the quorum report announcing that 11 brothers were present (11 in person and 0 via Zoom). He made a motion to waive the reading of the minutes from our last meeting as they were published in the department newsletter. The motion was seconded and approved by a voice vote. Additional announcements included an update on the 2025 dues with payments being received from 70% of the camp membership and the approval of two supplemental ancestors for Brother Robert Cox and one supplemental ancestor for brother Joel Normand. SVC Hooker and Brother Burgess provided a report on the Camp officer email address and engaged the membership for discussion on the topic. The current structure of the DSW email was discussed along with the various Google tools that are available. The Camp also discussed various officer email addresses and the update requirements necessary after the new slate of Officers was inducted.

#### A Forgotten Veteran's Struggle: Remembering Joseph R. Rennard and the Duty to Care By Avery Franz

The life and tragic death of Joseph R. Rennard, a Union veteran of the Civil War, reflects the trials faced by those who served and the enduring responsibility to care for veterans in need.

Born in 1847, Rennard joined Company I of the 47th New York Infantry at the age of 18. Enlisting in Brooklyn, New York, on February 27, 1865, his service carried him through the waning days of the Civil War. Mustered out at Goldsboro, North Carolina, on July 20, 1865, Joseph later attributed his lifelong struggle with rheumatism to his service in the humid Southern states. Seeking a new life after the war, Rennard headed west, working as a miner in the Arizona Territory. By 1886, he had settled in Bisbee and joined Kehoe Post of the Grand Army of the Republic. Declining health and increasing hardship eventually brought him to the Soldiers Home in Sawtelle, California, in 1905. Despite the care offered there, Joseph left the home on furlough, finding himself increasingly reliant on makeshift accommodations.

By February 1913, Rennard was living in a dilapidated shack behind a house at 318 W. Madison Street in Phoenix. Sharing this meager space with another Civil War veteran, Joseph frequently voiced complaints of ill health and a deepening sense of despair. Friends and acquaintances urged him to return to the Soldiers Home for better care, but the weight of his struggles proved overwhelming.

On February 26, 1913, Rennard took his own life with a .38-caliber blue steel revolver. Alone in his room around midday, he shot himself in the head. Hours later, his roommate returned to find smoke pouring from the shack. A coal from the fireplace had ignited the mattress, further obscuring the tragic scene. The fire scorched the mattress, blistered Joseph's body, and partially burned his face. When the smoke cleared and water was poured on the flames, Joseph was found clutching the revolver in his hand.

Joseph R. Rennard was buried in an unmarked grave at Greenwood Memory Lawn Cemetery in Phoenix. His final resting place remains a solemn testament to the overlooked struggles of many veterans in his time. Rennard's story underscores the challenges faced by aging veterans in an era when resources for mental health, physical rehabilitation, and elder care were severely lacking. His life, like that of many who wore the Union blue, reflects the deep sacrifices made during and after the war. While organizations like the Grand Army of the Republic worked to provide camaraderie and support, the systemic care veterans needed was too often unavailable.

Today, Joseph Rennard's life and death compel us to act. Veteran suicide and untreated mental health

conditions remain pressing issues. Just as important, we must ensure aging veterans receive the care and dignity they deserve. Efforts to mark graves like Rennard's are vital, not only to honor their service but to restore the humanity that may have been lost in life.

As members of the Sons of Union Veterans of the Civil War, we bear the legacy of our ancestors. Joseph Rennard's memory reminds us of the importance of ensuring no veteran feels forgotten or struggles alone. His story is a call to preserve their memory through action, advocacy, and care.


May we honor Private Joseph R. Rennard by committing ourselves to the well-being of all veterans, ensuring their sacrifices are never forgotten, and their dignity never neglected.
