Last known Greenlee County Survivor of the

Benjamin Franklin Wilson, late Private, Co. K, 5th Illinois Cavalry, has recently been identified as the last known survivor of the Civil War buried in Greenlee County, Arizona. He was born at Hodgenville, Kentucky, May 12, 1825, and died at Duncan, Greenlee County, April 6, 1913. At enlistment December 21, 1863, his residence was Liberty, Illinois.

Private Wilson mustered-in March 9, 1864 and was mustered-out at Springfield, Illinois, October 27, 1865. The prior last known survivor was James Almeron Richmond, late Private, Co. D, 103rd Ohio Infantry.

Thanks to information presented at its May 2018 Camp meeting from Department Graves Registration Officer David Jackson, the Camp is working on obtaining a government marker for Howard E. Banes. Specific information about the Camp activities can be found in the Grant Camp section of the newsletter but following is a biography of Banes prepared by Brother Jackson.

An Unmarked Grave Site of a Civil War Veteran Has Been Identified

The unmarked grave site of Howard Edward Banes has been identified by comparing information found on his Pension Application File card record to information found on his death certificate. That information was his name, date and place of death. An inquiry at the cemetery verified the burial site and confirmed his date of death. A search for Howard E. Banes grave site began when it was determined that he was a member of the James Scott Negley Post No. 1, Department of Arizona, Grand Army of the Republic, which was organized at Tucson. A search of online Arizona Voter Registration records verified that he was a long-time resident of Pima County, Arizona.

The Roster of members of the Department of Arizona, Grand Army of the Republic, shows that Howard E. Banes served in Company L, 3rd Colorado Cavalry (100 days, 1864). He enlisted August 18 at Nevada, Colorado Territory, and was mustered in at Camp Evans, Denver City, Colorado Territory, September 19, 1864. At his muster-in Howard stated that he was age 21 years and that he was born at Muskingum County, Ohio. He was described as 5 feet 11½ inches, with Hazel eyes, Sandy hair and Light complexion. Corporal Banes was mustered-out at Denver December 31, 1864.

Howard E. Banes filed from Arizona Territory for a pension October 9, 1899 and was enumerated, age 85 years, April 11, 1930, at Tucson. The enumeration shows that Howard was a widower, that his occupation was a Miner and he was a veteran of the Civil War. His death certificate shows that he was born July 10, 1845 and died February 4, 1930.

General R. H. G. Minty Camp No. 2 has raised funds for the installation of a Government headstone, which has been applied for by the cemetery, Evergreen Memorial Park located at Tucson. A time and date for a proceeding to mark the installation of a headstone marker for Howard E. Banes will be announced by Camp No. 2.

Speaker: Past Camp Commander David Swanson talked about the pre-territorial history of Arizona.

Arizona had a rich and colorful history along its path from being the Gadsden Purchase area of the Territory of New Mexico to statehood. Its preterritorial days are also an integral part of the history of New Mexico since New Mexico achieved territorial status in 1850 and Arizona didn't do so until 1863. Our hearty pioneers lived through lots of activity during this time—including fighting against Indians, lawless bandits, the U.S. Congress, and the invasion of Confederate forces from Texas; changes, in the form of pre-territorial boundaries and pre-territorial names such as Gadsden Purchase, Arizona—or Arizuma, the Confederate Territory of Arizona, and finally achieving *legal* territorial status as the U.S. Territory of Arizona in 1863.

A brief question and answer period followed his presentation and those present can answer this question: Did the "Territory of Arizona" really secede during the Civil War?"

General News and Information

A Short History of the Auxiliary to Sons of Union Veterans of the Civil War

The following information was obtained from *History of the Sons of Union Veterans of the Civil War 1881-1939*, by the Davis Star Camp, Soldiers and Sailors Memorial Hall, Pittsburgh, Pennsylvania. The first sentence in parenthesis noting the "History of the Auxiliary" is contained as written in the book. The article continues with a listing of National Presidents and that information is not contained in this paper since it available on the Auxiliary website.

I first compiled the information when the Picacho Peak Auxiliary No. 1 received its charter on August 23, 2014, and planned to present it—or at least publish it in the Picacho Peak Camp No. 1 newsletter, but I used alternate information and if not for the recent inquiry of Picacho Peak Auxiliary President Verna Maleski it may have remained buried.

OUR AUXILIARY

(Note: Taken largely from the History of the Auxiliary of the Sons of Union Veterans of the Civil War as prepared by Past National President, Molly D. Hammer, and approved by the Auxiliary.)

The "Big Brother" of our organization (the Auxiliary) was Major A. P. Davis of Pittsburgh. Through his efforts and interest the first Ladies' Aide Society was organized as an Auxiliary to the Sons of Veterans. This occurred at Philadelphia early in 1883, during the following year this Organization was recognized by the Sons of Veterans in the following resolution adopted at the Fourth Annual Encampment of the Commandry-in-Chief Sons of Veterans, August 28, 1884, held in Independence Hall, Philadelphia, Pennsylvania.

"Resolved, That the efforts of the Ladies' Aide Societies are truly appreciated by this Commandry-in-Chief, and that their work be heartily endorsed, and recommended to the various Camps under this jurisdiction."

The Ladies' Aide Society flourished in several States and a National organization was effected in 1886, with Miss Laura Martin, of Lancaster, Pennsylvania, as National President, and was completed as a National body at the First National Encampment of the Society held at Akron, Ohio, September 7-8, 1887, at which time eighteen delegates were present.

With the completion of the National body the Organization spread rapidly until it soon had Auxiliaries in practically all of the Divisions (as then called) of the Sons of Veterans.

The name Ladies' Aide Society was found not to be distinctive for its real purpose and working ideals and at the National Encampment held in Boston, Mass., in 1894, with the consent of the National body of Sons of Veterans, the name was changed to Sons of Veterans Auxiliary, and, later meeting the action of the Order of Sons of Veterans in its change of name, at the National Encampment held at Grand Rapids, Michigan, 1925, the name of the Auxiliary was changed to Auxiliary to Sons of Union Veterans of the Civil War. [The Sons of Veterans of the United States of America—also also known as the Sons of Veterans or Sons of Veterans U. S. A., was formed in 1881 and in 1923 its name was changed to Sons of Union Veterans of the Civil War.] The first of its worthy principles and objects reads, "To assist the Sons of Union Veterans of the Civil War, in all its principles and objects." To this end, the Auxiliary has continuously and consistently worked and has been of real value to the Sons of Union Veterans of the Civil War, performing distinctively patriotic work that can best be done by women.

It was early recognized by the Grand Army of the Republic as an allied order.

Its Annual Encampments have always been held at the same time and place as that of the Order of Sons of Union Veterans of the Civil War.

Westernmost Battle of the Civil War

The westernmost land battle of the Civil War, fought from February 20-21, 1862, occurred in the New Mexico Territory. Contrary to information contained in Wikipedia and other sources it was not the Battle of Picacho Pass (50 miles from Tucson) or the Battle of Stanwix Station (80 miles from Yuma). These were small skirmishes—especially Stanwix, that somehow, through a misinterpretation of the term "battle" (purposeful or not) became just that. I know; what a bummer! (Grief counselors are on standby.)

The name of the westernmost battle of the Civil War was the Battle of Valverde. And the battle nicknamed "Gettysburg of the West" was the Battle of Glorieta Pass fought a month later near Santa Fe. This battle was the "high-water mark" of the Confederate invasion of New Mexico and quickly put an end to its vision of Manifest Destiny.

Question:

Since the skirmish at Stanwix Station was the "westernmost skirmish of the Civil War" where does that leave the skirmish at Picacho Pass?
