As the Department's Signals Officer, I am happy to inform you that the Arizona State Library has determined that public documents issued by our SUVCW Department of the Southwest are historically significant, and they have added them to their Arizona Memory Project website:

Their website is (rigidly) formatted so that each "Contributing Institution" has its own web page. In our case, that's the link I've provided above. The link at the bottom of that page takes you to the Department's records, the "Collection" that they've posted to their site. As you can see, they've posted copies of all of the newsletters that are on our website, along with copies of some Arizona GAR history and Arizona Union veteran documents that are on our site.

This permanent presence on a state government website should improve our group's reputation and raise its public profile, while also helping to steer more Internet traffic to our Department website.

Opening

The meeting started at 11:30am on May 20, 2023 with 15 Brothers in attendance, 3 Guests (all Sisters of the DUVCW), and JVC Chad Newcomb attending via Zoom.

A Quorum was in attendance (6+) Members.

Commander Hoffay welcomed Brothers and guests to the meeting.

CC Hoffay led the rituals of Principles, Chaplin Heller the Invocation, CC Hoffay the America's Creed, CC Hoffay the Pledge of Allegiance.

The Meeting was called to order by Commander Hoffay.

S/T Lamb [gave the treasurer's report]. Details can be obtained by reaching out to the Interim S/T Ken Hooker.

ROTC/JROTC Officer Dan Huskisson reported on the activities of the camp's efforts to recognize Cadets for outstanding service. Dan covered a lot of ground all

over the state in his capacities of the office covering 21 schools across AZ. He also thanked our Sisters of the DUVCW for assisting in these efforts.

Old Business:

Brother David Jackson gave an update on the Porter Cemetery bench that we will be installing at the Pioneer Cemetery in Phoenix. The bench has been received by the cemetery but has not yet been installed. More to come on this in the coming months.

CC Hoffay asked for donations to purchase books from the collection of deceased Brother John Kohl (donated by his wife Joye).

CC Hoffay mentioned the Camp Happy Hour; we will be planning to hold a social gathering sometime in the upcoming months.

CC Hoffay mentioned the upcoming Memorial Day festivities at Pioneer & Military Memorial Park on 29 May and Brother Bob Cox will be onsite helping coordinate activities and the procession.

New Business:

Brothers Booth and Martorano were presented with certificates and Oak Leaf Cluster pins for their Supplemental Ancestors. They spoke about their ancestor's service to the Union Civil War efforts.

CC Hoffay presented a War Service Medal to Brother Scott Martorano.

Brother Richard Uplinger was initiated into our camp as a dual member, he has recently moved to the Phoenix area.

Department Commander Hooker gave an update from the Last Union Soldier Committee. The committee determined that Soldier Frances Weddle was not a Federalized Union Soldier, and therefore could not be the Last Union Soldier in Arizona. Parker Gordon is retained as the Last Union Veteran in Maricopa County and in AZ. DC Hooker thanks the committee for their service to this matter. The camp was represented by S/T Lamb on the committee.

DC Hooker presented a motion to accept the Camp bylaws with wording already accepted previously by the camp (regarding "good standing" of members) and reviewed by then Department Counselor John Conrad and verified valid. Hard copies were given of the actual wording for the vote. Motion was seconded. During discussion, Brother Lamb presented an alternate motion, to repeal DC Hooker's motion and table the issue for later discussion and send it to Department

PCC Brother Jeff Burgess gave a very interesting account of the Confederate Raid in Vermont, in and around Burlington. He described all the Civil War (and some American Revolution) history in and around that area of the country, with lots of detailed maps and photos in a riveting presentation.

There being no further business Chaplain Heller asked the blessing of our God on our deliberations.

CC Hoffay brought the meeting to a close until our next meeting August 19th 2023, at Mustang Library. This will be our annual joint meeting with the DUVCW.

Cpl. Reuben J. Bly, Co. A, 9th NY Cav: a longtime rancher in the Flagstaff area. He passed away at Brannen Ranch located about 6 miles north of Flagstaff. According to the newspaper he was "liked by

all" but had no family. "Headstone was placed in the Veteran Section as a Cenotaph in the 2000's"



Pvt. Leonidas Hill, Co. A, 23rd MO Inf: fought in the Battle of Shiloh and Missionary Ridge. He was then taken prisoner by the Confederacy and spent 13 months at Andersonville Prison. After the Civil War he moved to Arizona and began ranching. He was a member of the Ransom GAR post and was noted that "though his rough exterior, he had a kind heart."



Sgt. Patrick K. Noonan, Co. G, 69th PA Inf: born in County Cork, Ireland, about 1832. His family immigrated to the United States in the 1840's and settled in Pennsylvania. During the Civil War he enlisted as a sergeant at Philadelphia on May 5, 1861, and was mustered into Company G, 69th Pennsylvania Infantry; Sergeant Noonan was wounded in action at Gettysburg, July 3, 1863. While recovering from his wound, he enlisted as "Patrick Norton" and was mustered into Company G, 27th Pennsylvania Infantry, on August 17, 1863; he mustered out May 5, 1864. Patrick moved to the Arizona Territory in the 1870's and settled at Flagstaff. He was a member of Flagstaff's T. E. G. Ransom Post Grand Army of the

Republic, and was the first comrade to be buried by Ransom Post in the city's old Greenwood Cemetery. In 1914 his remains were transferred from Greenwood Cemetery to Citizens Cemetery.



Cpl. Lindsey Gibson, Co. G, 1st AR Inf: was born in Kentucky April 23, 1838. He joined the 1st Arkansas Infantry in 1863. His service was seen mostly in Arkansas fighting against Confederate General Sterling Price's troops. One notable conflict he was in was the Battle of Prairie D'Ane. In the 1870's he left Arkansas and moved to Texas where he was a laborer, later moving to Kingman, Arizona and then Flagstaff, Arizona where died from heart paralysis. He was a member of the GAR and his funeral was held at the Flagstaff GAR hall (located near the intersection of Beaver St. and Railroad Ave the site now occupied by Peace Surplus Outfitters.)



Sgt. Albert L. Giles, 32nd MA Inf.: served at Gettysburg, the Wilderness, Petersburg, Cold Harbor, Spotsylvania, and was present for the surrender of Robert E. Lee at Appomattox Court House.



Lt. Oliver Payne Harding, Co K, 89th NY Inf.: came to Flagstaff in 1884 from PA. He is known for constructing some of the first stone buildings in Flagstaff. According to the newspaper, "he was a jovial, genial man who gave what little he had and was pleased to give it." He passed away at the family home in Oak Creek.



Pvt. Milton Jones, Co E, 45th MO Inf.: born in KY but then later moved to MO where he served in the Civil War. He defended Jefferson City from the attacks of Confederate General Sterling Price. He moved to Flagstaff in 1898 but was in ill health for quite a long time before he passed away.

Pvt. Joseph Hoffman, Co F, 21st NY Cav.: born abt. 1843 in NY. He took part in the Battle of Lynchburg in 1864. Not much is known about Hoffman but that he was an early pioneer to Flagstaff when it was still a part of Yavapai County in 1889.

History of Sons of Veterans, United States of America Camps in Arizona & New Mexico

Currently, as far as I know, not much is known about the Sons of Veterans, USA Camps in Arizona and New Mexico, so I started a project to find them. So far I can say with certainty (and it would surprise me if there were others at this point) that there were four Camps as follows:

1886
Grant Camp No. 1 (Flagstaff)
1891
Phil Sheridan Camp No. 2 (Phoenix)
1901
R. H. G. Minty Camp No. 11 (Tucson)
1909
Kit Carson Camp No. 1 (Albuquerque)

Why should this be of importance to our Department? The Sons of Veterans, United States of America, also called the Sons of Veterans and the Sons of Veterans, USA, is the history of the SUVCW. It all started in 1881 and in 1925 the Sons of Veterans had a name change to Sons of Union Veterans of the Civil War. This is why two of the three current Camps—General R. H. G Minty and General U. S. Grant received their names.

So, as Paul Harvey used to say, "Stay tuned for the rest of the story."



Making Peace

The following was sent in by Brother Jim Cates Chickamauga, the name comes from a Cherokee word meaning "river of death," was the second bloodiest battle of the American Civil War. Fought in northwestern Georgia, just across the Tennessee state line, from September 18-20, 1863, there were 34,624 casualties, 28% of the 125,000 belligerents. 26 years later in 1889, 10,000 veterans from both sides came together in peace for the first Blue Gray Barbeque. As a result of this reunion, Congress created the first Civil War Battlefield Park.

Today, there are nearly 500 monuments commemorating people, military engagements, and military units. Most of the larger monuments were erected to memorialize the men of various states. The Kentucky Monument is unique. Kentucky, a border state, remained in the Union, but her sons fought on both sides. While other monuments are devoted to one side or the other, Kentucky's granite pillar honors her veterans from both sides. Rather than a Civil War soldier, the allegorical Bellona, goddess of war is atop a sphere resting on four cannons. An eagle spreads its wings over crossed Union and Confederate flags. Confederate and Union shields with laurel wreaths adorn the sides. The seal features two veterans shaking hands with the caption "UNITED WE STAND, DIVIDED WE FALL." The inscription reads "As we are united in life and they united in death, let one monument perpetuate their deeds, and one people forgetful of all asperities, forever hold in grateful remembrance all of the glories of the terrible conflict which made all men free and retained every star on the nation's flag." Almost by premonition, Kentucky's Monument Committee placed all adornments high on the tower, out of reach of potential vandals.

The first reunion of Blue and Gray Veterans was on October 19, 1875, in Elizabeth, NJ. The last was the

Blue Gray Encampment at Gettysburg from June 29-July 6, 1938. Veterans came together as brothers of one nation. On August 2, 1956, Albert Woolson, the last surviving Civil War Veteran, passed away at the age of 109 years. On December 16, 2020, Helen Jackson, wife of Union Veteran James Bolin, the last surviving Civil War widow, died at 101. The last child of a Civil War Veteran to die was 90-year-old Irene Triplett on May 31, 2020. Ironically, her father, Mose Triplett, served in both armies. Mose Triplett enlisted in the 26th NC Infantry in 1862. He was hospitalized with a fever on the march toward Gettysburg, sparing him from the battle that resulted in 734 casualties in a regiment of 800. Mose ran away from the infirmary, joining the 3rd NC Union Mounted Infantry. He died in 1939.

Civil wars have been among the most brutal conflicts in history. United States Veterans of both sides made peace. After all these years, in the spirit of the Kentucky Monument, today's Americans can also make peace.
