

A total of 15 Brothers present meeting quorum requirement of 6. Guests in attendance included Barbara Booth.

## Opening:

Junior Vice Commander Booth opened the meeting at 11:35am and Chaplin Heller provided the Invocation followed by all reciting the American's Creed and Pledge of Allegiance.

## Officer Reports:

Senior Vice Commander Hooker (SVC): SVC Hooker along with Brother Conrad discussed the upcoming DUVCW national convention and the request for support PPC1 has received. The daughters have specifically asked that we provide 35 escorts for their ceremonies on July 31st at 7:00pm. The SUVCW volunteer escorts will escort the DUVCW National officers to their seat at the opening of the ceremony which should end at approximately 8:30pm. The following 15 DSW brothers have volunteered and additional PPC1 volunteers are needed. Brothers Cox, Hooker, Conrad, Stephens, Prater, Hoffay, Frantz, Krause, Swanson, Rogers, Cuffel, Huskisson, Kampf, Martorano, and Booth.

## Secretary / Treasurer Martorano (ST): ST

Martorano provided the quorum report announcing that 15 brothers were present, 13 in attendance and 2 via Zoom. ST Martorano made two motions. First, a motion to correct a type error in the February 2024 minutes. Second, a motion was made to waive the reading of the minutes from our last meeting as they were published in the department newsletter. Both motions were seconded and followed by a voice vote in favor of each motion.

ST Martorano detailed the Camp membership as 57 total members, 55 of those are regular members and two associate members. Also, within the camp there are six life members. The 2024 gain/loss report reflects 5 gains and 8 losses.

ST Martorano was pleased to report that the annual Form 27 had been completed in a timely manner and date as detailed in the Camp bylaws. The annual per capita expense has been submitted to the department. The payment was

made, and the current balance in the Camp checking account was reported.

Junior Vice Commander Booth (JVC): JVC Booth discussed his current membership outreach efforts including his recent trip to Picacho Peak State Park which resulted in a lively discussion. Several brothers contributed their previous experiences at the park and thoughts regarding future participation at events.

JROTC Coordinator Huskisson: Brother Huskisson provided an overview of this year's JROTC awards presentation and acknowledged the efforts of those brothers and sisters that assisted him. Specifically, Brother Huskisson thanked Brother David Kampf and Sisters Maura Mackowski, Verna Maleski, Caroly Harris, Ginger Trokey and Carmen Wendt for their participation. In all 24 awards were presented.

Department Signals Officer Burgess: Brother Burgess updated the Camp regarding the status of the Department website, email, host and other related issues. Additionally, Brother Burgess discussed some of the challenges with the host service providers and the transition. Brother Martorano asked if the Department calendar had been removed from the site and Brother Burgess informed the Camp that it was removed due to some technical challenges.

## Old Business:

Brother Hooker provided the Camp with an overview of the March Department encampment with a brief description of the ceremonies and the overall success of the event. The feedback from the participants has been very positive and is the direct result of Department Commander Prater and all those who organized the event. Brother Hooker also informed the Camp that he will be taking over responsibility for the Department newsletter from Brother David Swanson. Brother Swanson has produced the outstanding newsletter for many years and will relinquish those responsibilities for future editions.

The Camp engaged in a discussion regarding the upcoming bench dedication event to be held at the Pioneer & Military Memorial Park Cemetery on Memorial Day, May 27<sup>th</sup>. Former Brother David Jackson, who organized the bench

procurement and placement, will be in attendance and Camp brothers are welcome to attend. At 8am Brothers will place a small U.S. flag at the grave of each Union veteran and those of several other wars. This will be followed by the bench dedication at 10am. Attending brothers should dress for the weather and wear their SUVCW badge and CW hat if available. The Camp was reminded about the Brother John Kohl Book Donation. To date the Camp has received approximately \$100.00 from the program.

#### New Business

The Camp discussed the need for a Grave Registrations Officer and the possible Grave Dedication for Jared Ryker at the Temple Double Butte Cemetery. Brother Booth volunteered to accept this appointed position. Brother Booth was presented with his 15<sup>th</sup> supplemental ancestor certificate and was congratulated by the Camp for his efforts to honor his ancestors.

The Camp discussed placing an ad in the DUCWV National convention brochure and was informed that the cost is \$50.00. After a discussion the Camp verbalized its desire to place the ad. A motion to approve the expense was made, seconded and approved by the membership to authorize the expense. The members of the Camp Council, Brothers Hooker, Cox and Burgess being in attendance, provided the Council's unanimous approval as

well. Brother Conrad volunteered to author the ad and present the final to the DUVCW for placement.

Bother Conrad provided the Camp with an overview of the Scottsdale Civil War Roundtable organization and upcoming presentation. The members expressed an interest in future participation and possible membership outreach. Brother Conrad to provide additional information on upcoming meetings.

#### Presentations:

Brother Ken Hooker gave a presentation on several artifacts associated with his ancestor General Hooker. In his possession and circulated among the attendees was an original General Order 194 from 1863. Brother Hooker detailed how these orders were issued and transmitted. He also explained the content of the order and gave historical context to a significant Civil War event.

Brother Burgess showed two short videos of his trip to the Manassas Battlefield. The videos included an 8-minute recording of a park ranger at the Stonewall Jackson statue explaining the origin of the famous nickname "Stonewall". Whether or not the description of Jackson as standing like a "stone wall" was a complement or not remains open to debate. Regardless, Jackson and his men certainly took pride in the descriptor and will be forever known as the "Stonewall Brigade".

## New Member Induction:

Brother Dominic Cuffel was formally inducted into Picacho Peak Camp 1 and gave a short presentation on his ancestor. Welcome Brother Dominic!

#### **DUVCW National Convention:**

Another topic is the 133rd National Convention of the DUVCW taking place in Scottsdale AZ 21 July through August 4th at the Embassy Suites hotel Scottsdale Rd. We talked about this in April. ## General Discussion:

S/T Enlow spoke about the recent SUVCW General Order #21 approving the membership / gender amendments to the Constitution and Regulations. Our own Department of the Southwest soundly rejected these amendments at the March 2024 Department Encampment, however; 19 Departments approved (63.3%), 10 disapproved (33.3%), and 1 did not vote (as reported in GO #21). Brother Enlow explained that the SUVCW Constitution only requires a majority (50%+1) of the Departments to ratify amendments. He pointed out that Article V of the US Constitution requires a 3/4 super majority of the states to ratify amendments. Constitutions should properly be an enduring and seldom changed document with a very high standard for amendments. A simple majority approval by Departments invites dissent, division, polarization, and disenfranchisement within the organization. "If it ain't broke...don't fix it!"

Motion: "I move that our Camp draft a resolution detailing our support for a proposed amendment to the SUVCW Constitution changing the current simple majority of Departments to a 3/4

ratification requirement. This draft shall be presented to the Camp at our October meeting, and if approved, sent to the Department of the Southwest Commander. Such proposed amendment could not be introduced until prior to the 2025 National Encampment."

The motion was properly seconded and passed.

## "Good of the Order" comments and discussion:

Tim Prater and Dick Melick introduced Barbara Fox-Thomas from the Yavapai County Board of Supervisor staff in recognition of her ongoing support for our Camp and in getting safety improvements installed at the Citizens

Cemetery exit onto Sheldon Street (a convex mirror and "Right Turn ONLY" signage). Huzzah! Commander Stephens then advised that due to scheduling we would postpone the presentation by Brother DeAtley until the next meeting.
