#### A Tribute to Brother Jerry Bloom, PDC

I was honored when Department Commander Todd Hoffay asked me to write about Brother Jerry Bloom in celebration of his upcoming 90th birthday (in June) and the current 30th year of his membership in the SUVCW. While he is no longer able to attend meetings, it's a privilege to recognize someone whose dedication, genuine camaraderie, wit and humor continue to inspire those around him.

I first met Gerald Nigh Bloom—known to virtually everyone as Jerry —when I joined Picacho Peak Camp No. 1 in 1999, and we've been friends ever since.

What has Jerry done over the years? Let's start in 1996 with the chartering of Picacho Peak Camp No. 1—it's only fitting to start here as Jerry was a charter member and has remained dedicated to it ever since. But his involvement doesn't stop there as he is also a charter member of the General R. H. G. Minty Camp No. 2, the General U. S. Grant Camp No. 3 and the Department of the Southwest!

And here is another remarkable detail: he joined the SUVCW as a Member-at-Large in September 1995 before Arizona had any Camps! Jerry is the only Brother in the Department of Arizona who is a charter member of all three Camps and the Department! No other Brother holds that distinction.

Besides being a charter member of everything, what else has he done? Well, once again we start with Picacho Peak Camp: In 2003 he took over the Secretary/treasurer office until 2015 when he became the Camp Commander. I remember this because I took over the Secretary/Treasurer office and I was sure happy when he took that job over again in 2016! Jerry continued to hold this office until 2022.

On August 22, 2015, the General U.S. Grant Camp held its first organizational meeting and Jerry offered to take on the Secretary/Treasurer office. The Camp was officially chartered in September 2015 and Jerry remained in that office until 2020 (he was still the Secretary/Treasurer of the Picacho Peak Camp during this time as well).

Department of the Southwest offices: On December 3, 2015 the Department of the Southwest was officially chartered and during its Special Encampment in March 2016 Jerry was elected to the office of Department Council. In 2017 he was the JVC, in 2018 the SVC, and in 2019, two month shy of his 84th birthday, Jerry was elected Department Commander.

This is just a short recap of some Brother Jerry Bloom's service to our Order. It doesn't include the many activities both on a Camp and Department level that he engaged in year after year (there isn't sufficient space in this newsletter).

So join me in wishing Brother Jerry Bloom, PDC, a very Happy (though slightly belated), 90th Birthday!

#### May 17, 2025, Camp Meeting Minutes

*Opening*: Commander Booth opened the meeting of the Picacho Peak Camp No. 1, SUVCW at 12:30pm and Chaplain James Heller being absent, SVC Hoffay provided the Invocation followed by all reciting the American's Creed and Pledge of Allegiance.

*Call to order*: Commander Booth declared the meeting officially open and welcomed all the members and guests.

#### S/T report:

ST Martorano provided the Quorum Report: In accordance with Article 7 (VII), Section 3 of the Picacho Peak Camp bylaws, Six Brothers shall be necessary to constitute a quorum at a regular or special meeting of this Camp. A total of 9 Brothers were present meeting the quorum requirement of 6. ST Martorano offered a motion to waive the reading of the Minutes from our February meeting as they have been published in the Dept Newsletter. Commander Booth asked for a second and the second was received. Placing the motion to the membership, the motion passed unanimously.

Secretary's report: ST Martorano informed the Camp that: -Currently PPC1 has 55 members (53 Regular, 2 Associates). -seven of our members are Life Members. -Loss / Gains year over year are 6 losses and 2 gains. ST Martorano also informed the Camp that Brother Jay R. Simons passed away on April 12, 2025. Brother Simons joined the SUVCW on September 19, 2003, and was the descendant of Herman Simon who served as a SGT in Co. K of the 66th NY Inf. Vols from September 1st, 1861, to Jan 28, 1863, when he was discharged with a disability after the Battle of Fredericksburg which occurred December 11-15, 1862. The 66th went into Fredericksburg with 238 men and had 75 killed, wounded or missing. Just over 30% casualties. Sgt. Simons had previously served at the Seven Days' Battle at the Peach orchard and Antietam where the unit lost approximately 150 men. ST Martorano stated that on behalf of Picacho Peak Camp 1, had expressed condolence to Brother Simon's family, notified and spoke with Chaplain Heller who will be sending a sympathy card, and would also be issuing the proper condolence certificate from the Camp. The Camp expressed its gratitude for the comradery we were able to share with Brother Simon over the last 21 years, he will be missed.

Treasurers Report: ST Martorano was pleased to report the following: Our Camp finances remain strong, and the current balance of our checking account was reported. Our annual Form 27 has been filed with the Department of the Southwest to determine and report on our per capita dues, which werer eported. The payment has been made and processed by the department. The Camp voted in February of this year to establish a memorial fund with donations to be dedicated to the

Civil War Union Veteran William Green Remembrance fund established by the DSW order # 5 in 2024. After our initial donations we received two additional donations. USG3 generously donated \$250.00 and the Silent auction at the Department encampment raised \$261.00. Our memorial fund now has a balance of \$701.00.

Junior Vice Commander:

JVC Cox reported on the new member recruitment activities since our February meeting and invited the membership to seek all opportunities to help identify potential members.

#### JROTC Coordinator:

Brother Huskisson not being present provided a report that was read by ST Martorano and included the following: - 20 awards were presented to JROTC students in the greater Phoenix area. Unfortunately, three potential awards could not be presented for various reasons. Brother Huskisson offered a special thank you to Brother Kampf, Brother Cox, Sister Maura Mackowski, Sister Verna Maleski and Sister Ginger Trokey for assisting with the award presentations.

Secretary's Report: Commander Stephens advised that the minutes of the April Camp meeting had been distributed to all Brothers and no additions or corrections had been received. A motion to approve as distributed was seconded and passed.

*Treasurer's Report:* the 2025 2nd Quarter report has been completed and approved by the Camp Council and Commander Stephens. Current checking account balance was reported, and the JROTC Scholarship / General Fund stands at \$930.50. Two \$1000 scholarship awards have been delivered to Payton Tachenne NAU) and Brigid Enlow (St. Louis Univ.) Camp membership now stands at 45 total members / 40 Primary. General Orders: S/T Enlow advised there were 5 National General Orders, and one Department Order, issued since our last meeting. All orders have been forwarded to the membership. #### Old Business:

Last Union Veteran marker ceremony in Winslow, AZ was held with several descendants of Lt. David Hart present. All gathered after the ceremony at the Turquoise Room in the historic La Posada Hotel for lunch, which the Camp provided to the family members. Plans are still underway for markers in Apache and Mohave Counties



Commander Stephens advised that there was no news on the project to secure and install a headstone and GAR marker on the unmarked pauper's grave of Pvt. William Green inn Phoenix. The Camp had donated \$250 to Picacho Peak Camp toward this project. PDC Prater and Brother Steve Bigelow gave updates on the 2025 ROTC / JROTC Awards presentations and advised of the current challenges due to National's centralizing the distribution of all certificates and medals. This resulted in several delays and embarrassing errors.

Commander Stephens advised that the Camp was active in 3 separate Memorial / Decoration Day Ceremonies at:

-Camp Navajo Veterans Cemetery, Bellmont, AZ where David Swanson PDC delivered the Gettysburg Address -Prescott Citizens' Cemetery where PDC Tim Prater delivered the Gettysburg Address and several Camp Brothers participated in the parade procession. -Prescott National Cemetery where S/T dale enlow delivered the Gettysburg Address and Commander Rick Stephens and his wife Laura presented the Gold Star Family wreath at the unknown soldier monument.



Commander Stephens gave an update on the National SUVCW Encampment in August. He, David Moore and Minty Camp Brother Mark Clark are attending as Department of the SW Delegates.

#### New Business:

Brothers Prater and Poehlmann advised we are getting much more involved with the Eagle Scout recognition program.

Of the 15 presentations this year, 11 were by Gen'l. US Grant Camp.

New Brother Gregg Poehlmann was named as the Camp Eagle Scout Coordinator replacing PDC Prater.

Commander Stephens reminded the Camp Council, that Camp officer elections will take place at our October Quarterly meeting and the Council is responsible to seek and present a slate of nominees for the 2026 elected positions in advance of that meeting. Volunteers are needed to fill these positions

#### The Gettysburg Address:

Delivered by President Abraham Lincoln on November 19, 1863, during the dedication of the Soldiers' National Cemetery in Gettysburg, Pennsylvania. This important speech was recited by four of our Brothers From the Department of the Southwest on Memorial Day, May 26th, 2025 in four different locations across the State of Arizona! Text of the speech:

Four score and seven years ago our fathers brought forth on this continent, a new nation, conceived in Liberty, and dedicated to the proposition that all men are created equal. Now we are engaged in a great civil war, testing whether that nation, or any nation so conceived and so dedicated, can long endure. We are met on a great battle-field of that war. We have come to dedicate a portion of that field, as a final resting place for those who here gave their lives that that nation might live. It is altogether fitting and proper that we should do this.

But, in a larger sense, we can not dedicate—we can not consecrate—we can not hallow—this ground. The brave men, living and dead, who struggled here, have consecrated it, far above our poor power to add or detract. The world will little note, nor long remember what we say here, but it can never forget what they did here. It is for us the living, rather, to be dedicated here to the unfinished work which they who fought here have thus far so nobly advanced. It is rather for us to be here dedicated to the great task remaining before us-that from these honored dead we take increased devotion to that cause for which they gave the last full measure of devotion—that we here highly resolve that these dead shall not have died in vain—that this nation, under God, shall have a new birth of freedom—and that government of the people, by the people, for the people, shall not perish from the earth.
