for Union Civil War Veteran Corporal Howard E. Banes**

Corporal Howard E. Banes—Headstone Ceremony

All the Camps and Allied Orders in the Department of the Southwest, along with members of the 1st New Mexico Company b reenactors, were represented in General R. H. G. Minty Camp #2's headstone ceremony for Corporal Howard E. Banes of the 3rd Colorado Cavalry.



Howard E. Banes enlisted August 18 at Nevada, Colorado Territory. He was mustered in Company L, 3rd Colorado Cavalry (100 days, 1864), at Camp Evans, Denver City, Colorado Territory. At his muster-in Howard stated that he was age 21 years and that he was born at Muskingum County, Ohio. He was described as 5 feet 11 ½ inches, with Hazel eyes, Sandy hair and Light complexion. Company L was commanded by Captain John Freeman Phillips. Corporal Banes was mustered-out at Denver December 31, 1864. Corporal Banes passed away February 4, 1931 and from then until TODAY his grave has been unmarked.

Funds were raised for installation, the headstone ordered, and on September 29th at 9:00 AM in Tucson, AZ, Corporal Banes was remembered for his service during the Civil War. A burial flag will be sent to a descendant of Corporal Banes living in Vermont.



Message from Department Commander Bob McCord

Let me start by saying how excited I am at hearing that all five of the allied orders now have a presence in Arizona. Great job ladies! I believe that I speak for the Department when I say that we consider you all to be part of the Department family, and that the Sons stand ready to help you however possible.

I had many notes to share with you about the National Encampment, but the new CinC has done a good job of informing the general membership through his series of General orders, if you have not read them, do so! What I have left is a series of notes that I'll share with you now:

There was a change to C&R to require Camps and Departments have an assistant Secretary/Treasurer Memorial University is undergoing a redesign to be easier to do and all around better. If you are not familiar with Memorial University, I think of it as Camp Officer OCS. I think it is very valuable in its present form, but looks to be great as the redesign was presented.

Camp officer installation has been changed to between September to January. The position of SVR Quartermaster has been created and SVR items will no longer be handled by the SUVCW Quartermaster. SVR Unit Commander, Past Commander and Past District Commander badges have been created and authorized.

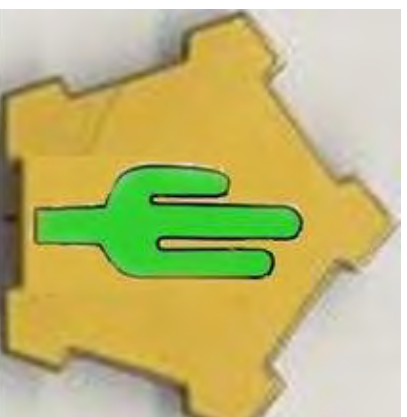
Let me take this opportunity to present two ideas, to get a 'sense of the Department' from you, the membership of the Department. If interest is at or near zero, fine, we'll let it drop, but if there is interest, details will be hammered out, officers consulted, etc. Is there interest in the Sons of Veterans Reserve? They are ceremonial uniformed military component of the SUVCW. I know of several department members who are members of out of state units, and it seems to me that now is a good time to ask: is the interest in a unit here? I'll volunteer to help organize formative meetings, but I am not looking for a leadership position. Someone with more knowledge of uniforms, weapons, the local reenactment community, and the SVR (or at least some of those things) should do that. I've already contacted several individuals in the Fifth Military District (to which we would belong) who have volunteered to help. Please drop me an email if you are interested! I'll use that to gauge interest, and to have your email to contact you if it looks like there is enough interest.

My second item is a Department Badge. These are modeled after the Corps Badges worn during the Civil War. Many departments have them. Like the Corps badges these would be worn to identify us, and to show our pride in the department. I envision a badge not

more than 1.5 inches in size, to resemble the originals and be worn on the hat or uniform, as a lapel pin, or (as provided by the regulations) to be worn on the PDC ribbon. This would in no way forbid members from making, say, a large version in felt to be worn on the Kepi top (as was done originally). I really have no preconception on what this should look like—I just think that we should have one. However, I know if you do not throw something out there to inspire or enrage nothing often happens, so here are some thoughts: What did the Arizona GAR do? Well as far as I can tell they never had a department badge, but I have discovered three instances where they manufactured a ribbon for department encampments and those ribbons had a cactus or cacti hand painted on them. Translated to a badge I can imagine a silhouette of a green saguaro.

What do other departments do? This varies, but the most common is to use a corps badge that had significant contributions from that state in that corps. Issues are most of the original corps badges have been spoken for by other departments and Arizona is not noted for contributing a whole lot of troops to the Civil War. Then in occurred to me that the corps badges of the Spanish American War were different than the Civil War, and that war had a corps that fit the bill: the cavalry division of the Fifth Corps. This was the division that had the First Volunteer Cavalry (the Roughriders) in it, a strong Arizona, New Mexico presence. It also had the 9th and 10th Calvary in it, both units with a strong southwest connection.

I presented all this to a Minty Camp meeting and several weeks later Br. Randy McNally sent me a message and said, 'Why don't you put these two ideas together?' Here is an image of the result. The final version would likely have a gold, rather than black, outline around the saguaro.



What do you think? Love it, hate it, have another design? Let me know! I'm just trying to gauge interest and get a design that folks like.

Thanks to all of you. Keep doing what you are doing, it’s great. Remember the department is not an abstraction or a couple of officers, the department is you, the membership making the department look good in your activities.

August 18, 2018 Camp meeting:

It also memorializes all who lost their lives in the conflict. It contains stones sent from all 36 states that were in existence at the end of the Civil War. She brought back an Indiana limestone shard from the cenotaph and presented it to Commander Heller as a gift from her and the Daughters.

What famous Civil War General had the initials H. U. G.?

Hiram Ulysses Grant was born on April 22, 1832. During his childhood his preference for a first name was Ulysses because of the taunting of other boys because of the H. U. G. initials.

Now fast forward to West Point. Jesse Grant, his father, decided that his son should attend West Point (without consulting him) and wrote his request to Ohio senator Thomas Morris. Morris thought it was fine but Jesse had to write to his congressman Thomas Hammer who had to nominate him.

As Ron Chernow wrote in his book *Grant* "In his haste he listed the applicant as Ulysses S. Grant. The confusion came about either because Hammer confused Ulysses with his younger brother Simpson or because he assumed Ulysses was his first name and he had taken Hanna's (his mothers) maiden name for his middle name. (Grant himself blamed Senator Morris for the long-lived error). The mistaken name which persisted at West Point and beyond, was the bane of the young man's life . . . Grant, years later, wrote to his wife and said 'You know, I have an 'S' in my name and I don't know what it stands for.'

"Upon arrival at West Point, Grant registered under the name Ulysses Hiram Grant [to get away from the H. U. G. initials] but since he was nominated under Ulysses S. Grant fate had intervened and . . . four years later he had capitulated to the tyranny of the clerical error and adopted Ulysses S. Grant as his new moniker for life"

Grant was not happy about his father's actions and later wrote: "My appointment was an accident, and my father had to use his authority to make me go."

So, we all owe Jesse Grant a debt of gratitude because without his son being sent to West Point who knows how the War of the Rebellion would have turned out!
