As you can see by the "TO:" line of this email there were many at the camp and department level who participated from every part of our country. You coordinated with over a thousand high schools, colleges, universities and military academies to give our certificate, medal and ribbon to deserving cadets. The feedback I have received from those schools over the past three years is a testimony to your hard work at the local level.

This year our numbers were a bit down no doubt due to the edict put out by the headquarters of the Air Force Junior ROTC. My communication with several unit commanders indicate that they are hopeful this edict will be reversed in the future, but still our production was very good!

I have attached a bar chart to this email that will demonstrate the hard work by each department. It is for the year May 1, 2018 thru April 30, 2019. I took over the program in May, 2016 so that is where my record keeping began. Enjoy what you see; give yourselves a pat on the back.

If after a search request has been completed and a determination is made that that the record is not correct an edit of that record can be suggested. Submit requests for a suggested edit to the Department's Graves Registration Officer at dgrosouthwest@suvcwdb.org.

Nine hundred plus and counting! The number of Arizona burials in the SUVCW National Graves Registration Database has grown to 904. At the time of the Department's first Encampment during March 2016 the number of Arizona burials in the Database was 568.

The August 17, 2019, Camp meeting was opened at Noon by camp Commander Jeff Burgess.

Verna Griffith (Camp Auxiliary) and Ginger Trokey (DUVCW) were recognized in attendance. SUVCW brother John Kind visited again from El Paso, TX. New brother Stephen Miller was introduced. Probable new brother (transfer) Gordon Struve was introduced. Laura McCord, wife of Brother Bob McCord of the Gen. R.H.G. Minty Camp, attended and was offering the new Dept. of the Southwest badges for \$5. (Her email address is ncsljm@aol.com if you are interested.)

Officer Reports:

Camp Secretary/Treasurer Jerry Bloom reported that the Camp's finances are in good health. He had attended the National Encampment in Cleveland the previous weekend with Camp brother John Conrad. He reported that the national SUVCW had mandated that all departments and camps must now have an Assistant Secretary/Treasurer. He asked for volunteers to be the Camp's Assistant Secretary/Treasurer to contact him. He said it would be good if they had Excel software skills.

Brother Bloom and Conrad then discussed the SUVCW's status as a 501(c)(3) charitable organization, making all contributions to it tax deductible. They explained that this status has, so far, only been achieved by the national SUVCW, and that

the national office was working on getting this tax status approved for all of the departments and camps.

Camp Graves Registration Officer Avery Frantz provided an update on the two new gravestones he had procured for two Union veterans at Tempe's Double Butte Cemetery. Dedication ceremonies, including media coverage, are planned this fall, after the weather cools down.

Department JROTC Coordinator Bob Archibald gave an update on the Department's robust JROTC program. He explained that the U.S. Air Force had recently issued a regulation that no member could wear "ancestry based" medals or badges on their uniforms. This will not stop the SUVCW, however, from continuing to distribute medals to JROTC graduates.

Past Camp Commander David Swanson explained that the Department's newsletter was slightly delayed, but would go out later this month.

Old Business

The new Dept. of the SW business cards, designed by Camp Council Kenneth Hooker, are undergoing review by the national office, per brother Bloom.

New Business

Department Graves Registration Officer David Jackson was unable to project the video he created about the ancestors of General R. H. G. Minty Camp #2 because the room was too bright. He explained, however, that it could be reviewed on the Department's website at: https://suvcwsouthwest.org/minty-camp-2/ He also explained that he was working on similar videos for the Department's Picacho Peak and U.S. Grant camps, and they would also be posted to the website after they are completed.

Sister Ginger Trokey announced that the Margaret Warner Wood Tent #1 of the DUVCW is asking for support for two charitable programs: § Wreaths Across America § AZ State Veteran Home Donations.

Featured Speaker Camp Commander Jeff Burgess was also unable to project a video he had created about the Union soldier monuments he had seen while visiting the State of Vermont in June because the room was too bright. Perhaps the most significant news was that an SUVCW Signal Corp has been formed comprised of brothers with computer skills to take better advantage of the Internet and social media to promote the SUVCW. Union Forces had 195,000 POW/MIAs and the Confederacy had 215,000. Let us never forget those who paid the ultimate sacrifice in defense of our Nation.

September 20, 2019 National POW/MIA Recognition Day is an observance that honors those who were U.S. Prisoners of War (POW) as well as those who are still missing in action (MIA). It is observed in the United States on the third Friday in September.



Ransom Post No. 4 (Flagstaff) GAR document

Quite some time ago I ran across the following GAR document online dated 1889 from Flagstaff, Arizona Territory that I found quite interesting.

The printed document has "Honorable Discharge", but it has been neatly lined out with red ink, and above it is written "Transfer Card". Embossed at lower left, "Ransom Post No. 4 G.A.R. Flagstaff Arizona, chartered Aug 20th 1884" (the Post was then part of the Department of California GAR. The Department of Arizona GAR became official on January 17, 1888). Above the embossment is: "Offices held in the GAR—Aide de Camp on Dept Commander Staff 1889."

The text reads: "Grand Army of the Republic. Department of Arizona Headquarters Ransom Post No. 4. To Any Post of the Grand Army of the Republic, Greeting: This Certifies that comrade Culver Marshall is a member in good standing of this Post, and having paid all dues, we have granted him this Transfer Card and recommend him for admission into any Post of our Order. The Following is a Correct Transcript from the Records of the Post: Comrade Culver Marshall is 56 years of age, was born in Pleasant Valley State of New York and is by occupation a R.R. Bridge Inspector entered the service on the 20th day of June 1863 as a Private in Co. D 13th Regt. New York State Militia and was finally discharged on the 15th day of May 1865 as Quarter Master Sergeant Co. "C" 1st Regt. New Jersey Cavalry by reason of Gen'l Order #94 May 15th 1865 having served Two years and no months. Joined this Post by Muster in November 10th 1888. Dated at Flagstaff A.T. this 31st Day of December 1889." Signed by Wm. D. Powell, Adjutant, and J. B. Smith, Post Commander.
